# ON SOME PROPERTIES OF MODULATION SPACES AS BANACH ALGEBRAS

#### Abstract

In this paper, we give some properties of the modulation spaces $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ as commutative Banach algebras. In particular, we show the Wiener-Lévy theorem for $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, and clarify the sets of spectral synthesis for $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ by using the "ideal theory for Segal algebras" developed in Reiter [30]. The inclusion relationship between the modulation space $M_{0}^{p, 1}(\mathbf{R})$ and the Fourier Segal algebra $\mathcal{F} A_{p}(\mathbf{R})$ is also determined.


## 1. Introduction

A commutative Banach algebra is a Banach space $\left(X,\|\cdot\|_{X}\right)$ which is a commutative algebra, i.e., with an associative, distributive and commutative multiplication satisfying $\|f g\|_{X} \leq\|f\|_{X}\|g\|_{X}$ for all $f, g \in X$. There are many examples of commutative Banach algebras. For this paper the Fourier algebra $A(\mathbf{R})$ is an important example, i.e., the set of all functions on $\mathbf{R}$ which are the Fourier transforms of functions in $L^{1}(\mathbf{R})$, is a commutative Banach algebra with pointwise multiplication, denoted by $\mathcal{F} L^{1}(\mathbf{R})$ elsewhere. In addition, the Wiener algebra $A(\mathbf{T})$, which corresponds to a periodic version of $A(\mathbf{R})$, and the Fourier-Beurling algebra $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)(s \geq 0)$, which can be regarded as a generalization of $A(\mathbf{R})$, are commutative Banach algebras (see Section 2.3 for the definition of $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$ ). As is well known, those function spaces play important roles in various fields such as commutative Banach algebras, operating functions, and spectral synthesis. We refer the reader to Kahane [19], Katznelson [20], Reiter [30], Reiter-Stegeman [31] and Rudin [32] for more details.

On the other hand, modulation spaces $M_{s}^{p, q}\left(\mathbf{R}^{n}\right)$ form a family of function spaces introduced by Feichtinger [9] (see Definition 2.1). In some sense, they behave like the Besov spaces $B_{s}^{p, q}\left(\mathbf{R}^{n}\right)$. But they appear to be better suited for the description of problems in the area of

[^0]time-frequency analysis and are often a good substitute for the usual spaces $L^{p}\left(\mathbf{R}^{n}\right)$ or $B_{s}^{p, q}\left(\mathbf{R}^{n}\right)$ (see [14], [17] for more details). It is important for our considerations that $M_{s}^{p, q}\left(\mathbf{R}^{n}\right)$ is a commutative Banach algebra if $s>n\left(1-\frac{1}{q}\right)$, or $q=1$ and $s \geq 0$ (cf. [13], Theorem 10), and that it appears naturally in the study of certain partial differential equations. For example, we can solve the nonlinear Schrödinger equations $i u_{t}+\Delta u=|u|^{2 k} u$ in $M_{s}^{2,1}\left(\mathbf{R}^{n}\right)$ for all $k \in \mathbf{N}$ by using the algebraic properties of $M_{s}^{p, q}\left(\mathbf{R}^{n}\right)$ (see [1], [37]). Furthermore, as a commutative Banach algebra, $M_{s}^{p, q}\left(\mathbf{R}^{n}\right)$ satisfies many interesting properties similar to $A(\mathbf{R}), A(\mathbf{T})$ and also $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$ (cf. [2], [3], [21], [22], [23], [29]). Therefore, it is of interest to further clarify the properties of $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$.

In this paper we study several properties of $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ as a commutative Banach algebra. In particular, we will establish the validity of the Wiener-Lévy theorem for $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, and see that the sets of spectral synthesis for $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$ coincide with those for $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, independently from $p$ (given the general restrictions). Moreover, we will consider the inclusion relation between the modulation space $M_{0}^{p, 1}(\mathbf{R})$ and the Fourier Segal algebra $\mathcal{F} A_{p}(\mathbf{R})$.

The organization of this paper is as follows. After a preliminary section devoted to the definition and basic properties of $M_{s}^{p, q}\left(\mathbf{R}^{n}\right)$ and $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$ we will demonstrate in Section 3 that there exist approximate units for $M_{s}^{p, q}\left(\mathbf{R}^{n}\right)$ (see Theorem 3.1). In Section 4 we consider the closed ideals in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ and prove that closed modulation invariant subspaces of $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ coincide with closed ideals in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. Section 5 is devoted to the Wiener-Lévy theorem, which was originally proved by Wiener [38] and by Lévy [26] for $A(\mathbf{T})$. In particular we will show that the Wiener-Lévy theorem and also Wiener's general Tauberian theorem hold for $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ if $1 \leq p<\infty$ and $s \geq 0$ (see Theorems 5.1 and 5.61). In Section 6 we will consider the set of spectral synthesis for $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. By using the "ideal theory for Segal algebras" developed in Reiter [30] we will clarify the relation between the sets of spectral synthesis for $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ and the sets of spectral synthesis for $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$ (see Theorem 6.3). In Section 7 we will prove that single points of $\mathbf{R}^{n}$ are sets of spectral synthesis for $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ without using Theorem 6.3, Finally, in Section 8 we will determine the inclusion relation between $M_{0}^{p, 1}\left(\mathbf{R}^{n}\right)$ and the Fourier Segal algebras $\mathcal{F} A_{p}\left(\mathbf{R}^{n}\right)$.

## 2. Preliminaries

The following notation will be used throughout this article. We use $C$ to denote various positive constants which may change from line to line. We use the notation $I \lesssim J$ if $I$ is bounded by a constant times $J$ and we
denote $I \approx J$ if $I \lesssim J$ and $J \lesssim I$. The closed ball with center $x_{0} \in \mathbf{R}^{n}$ and radius $r>0$ is defined by $B_{r}\left(x_{0}\right)=\left\{x \in \mathbf{R}^{n}| | x-x_{0} \mid \leq r\right\}$. For $x \in \mathbf{R}^{n}$, we write $\langle x\rangle=\left(1+|x|^{2}\right)^{\frac{1}{2}}$. We define for $1 \leq p<\infty$ and $s \in \mathbf{R}$

$$
\|f\|_{L_{s}^{p}}=\left(\int_{\mathbf{R}^{n}}\left(\langle x\rangle^{s}|f(x)|\right)^{p} d x\right)^{\frac{1}{p}}
$$

and $\|f\|_{L_{s}^{\infty}}={\operatorname{ess} . \sup _{x \in \mathbf{R}^{n}}\langle x\rangle^{s}|f(x)| \text {. We simply write } L^{p}\left(\mathbf{R}^{n}\right) \text { instead }}$ of $L_{0}^{p}\left(\mathbf{R}^{n}\right)$. For $1 \leq p<\infty$, we denote by $p^{\prime}$ the conjugate exponent of $p$, i.e., $\frac{1}{p}+\frac{1}{p^{\prime}}=1$. We write $C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ to denote the set of all complexvalued infinitely differentiable functions on $\mathbf{R}^{n}$ with compact support. We write $\mathcal{S}\left(\mathbf{R}^{n}\right)$ to denote the Schwartz space of all complex-valued rapidly decreasing infinitely differentiable functions on $\mathbf{R}^{n}$ and $\mathcal{S}^{\prime}\left(\mathbf{R}^{n}\right)$ to denote the space of tempered distributions on $\mathbf{R}^{n}$. We use $\langle F, G\rangle$ to denote the extension of the inner product $\langle F, G\rangle=\int F(t) \overline{G(t)} d t$ on $L^{2}$ to $\mathcal{S}^{\prime} \times \mathcal{S}$ or $M_{s}^{p, q} \times M_{-s}^{p^{\prime}, q^{\prime}}$ (see Lemma 2.2 (ii) below). The Fourier transform of $f \in L^{1}\left(\mathbf{R}^{n}\right)$ is defined by

$$
\mathcal{F} f(\xi)=f^{\wedge}(\xi)=\widehat{f}(\xi)=\int_{\mathbf{R}^{n}} f(x) e^{-i x \xi} d x
$$

Similarly, if $h \in L^{1}\left(\mathbf{R}^{n}\right)$ then the inverse Fourier transform of $h$ is defined by $\mathcal{F}^{-1} h(x)=(2 \pi)^{-n} \widehat{h}(-x)$. We note that $\langle f, g\rangle_{L^{2}\left(\mathbf{R}^{n}\right)}=$ $(2 \pi)^{-n}\langle\widehat{f}, \widehat{g}\rangle_{L^{2}\left(\mathbf{R}^{n}\right)},(f * g)^{\wedge}=\widehat{f} \widehat{g}$ and $(f g)^{\wedge}=(2 \pi)^{-n}(\widehat{f} * \widehat{g})$, where $(f * g)(x)=\int_{\mathbf{R}^{n}} f(x-y) g(y) d y$. Moreover, $M\left(\mathbf{R}^{n}\right)$ denotes the sets of all bounded regular Borel measures $\mu$ on $\mathbf{R}^{n}$ with the norm

$$
\|\mu\|_{M\left(\mathbf{R}^{n}\right)}=\sup _{f \in C_{c}\left(\mathbf{R}^{n}\right),\|f\|_{L^{\infty} \leq 1} \leq 1}\left|\int_{\mathbf{R}^{n}} f(x) d \mu(x)\right|
$$

The Fourier-Stieltjes transform of $\mu$ is defined by $\widehat{\mu}(\xi)=\int_{\mathbf{R}^{n}} e^{-i x \xi} d \mu(x)$. Here $C_{c}\left(\mathbf{R}^{n}\right)$ denotes the set of all $f \in C\left(\mathbf{R}^{n}\right)$ with compact support. Let $\delta_{a}\left(a \in \mathbf{R}^{n}\right)$ be the unit mass concentrated at the point $x=a$, i.e., $\delta_{a}(E)=1$ if $a \in E$ and $\delta_{a}(E)=0$ otherwise. Then we have $\delta_{a} \in M\left(\mathbf{R}^{n}\right),\left\|\delta_{a}\right\|_{M\left(\mathbf{R}^{n}\right)}=1, \widehat{\delta_{a}}(\xi)=e^{-i a \xi}$ and $\delta_{a} * \delta_{b}=\delta_{a+b}\left(a, b \in \mathbf{R}^{n}\right)$ (see [32, Ch.1.3] for more details). For two Banach spaces $B_{1}$ and $B_{2}$, $B_{1} \hookrightarrow B_{2}$ means that $B_{1}$ is continuously embedded into $B_{2}$.
2.1. Short-time Fourier transform. For $f \in \mathcal{S}^{\prime}\left(\mathbf{R}^{n}\right)$ and $\phi \in \mathcal{S}\left(\mathbf{R}^{n}\right)$. the short-time Fourier transform $V_{\phi}$ of $f$ with respect to the window $\phi$ is defined by the duality expression

$$
V_{\phi} f(x, \xi)=\left\langle f, M_{\xi} T_{x} \phi\right\rangle=\left\langle f(t), \phi(t-x) e^{i t \xi}\right\rangle=\int_{\mathbf{R}^{n}} f(t) \overline{\phi(t-x)} e^{-i t \xi} d t
$$

where the translation operator $T_{x}$ and the modulation operator $M_{\xi}$ are defined by $\left(T_{x} h\right)(t)=h(t-x)$ and $\left(M_{\xi} h\right)(t)=e^{i t \xi} h(t)$, respectively.

It is known that $V_{\phi} f \in C\left(\mathbf{R}^{n} \times \mathbf{R}^{n}\right)$ (see [17, Lemma 11.2.3]) and

$$
\begin{equation*}
V_{\phi} f(x, \xi)=(2 \pi)^{-n} e^{-i x \xi} V_{\widehat{\phi}} \widehat{f}(\xi,-x)=(2 \pi)^{-n} e^{-i x \xi}\left(f * M_{\xi} \phi^{*}\right)(x), \tag{1}
\end{equation*}
$$

where $\phi^{*}(x)=\overline{\phi(-x)}$ (see [17, Lemma 3.1.1]). We also note that if $f \in \mathcal{S}\left(\mathbf{R}^{n}\right)$, then $V_{\phi} f \in \mathcal{S}\left(\mathbf{R}^{n} \times \mathbf{R}^{n}\right)$ (see [17, Theorem 11.2.5]). Moreover, we have Moyals Equation:

$$
\left\langle V_{\phi} f, V_{\psi} g\right\rangle_{L^{2}\left(\mathbf{R}^{2 n}\right)}=(2 \pi)^{n}\langle\psi, \phi\rangle_{L^{2}\left(\mathbf{R}^{n}\right)}\langle f, g\rangle_{L^{2}\left(\mathbf{R}^{n}\right)}
$$

for all $f, g, \phi, \psi \in L^{2}\left(\mathbf{R}^{n}\right)$ (see [17, Theorem 3.2.1]).

### 2.2. Modulation spaces.

Definition 2.1 ( 9$]$ ). Let $1 \leq p, q \leq \infty, s \in \mathbf{R}$ and $\phi \in \mathcal{S}\left(\mathbf{R}^{n}\right) \backslash\{0\}$. The modulation space $M_{s}^{p, q}\left(\mathbf{R}^{n}\right)=M_{s}^{p, q}$ consists of all $f \in \mathcal{S}^{\prime}\left(\mathbf{R}^{n}\right)$ such that the norm

$$
\|f\|_{M_{s}^{p, q}}=\left(\int_{\mathbf{R}^{n}}\langle\xi\rangle^{s q}\left(\int_{\mathbf{R}^{n}}\left|V_{\phi} f(x, \xi)\right|^{p} d x\right)^{\frac{q}{p}} d \xi\right)^{\frac{1}{q}}
$$

is finite (with usual modification if $p=\infty$ or $q=\infty$ ). We simply write $M^{p, q}\left(\mathbf{R}^{n}\right)$ instead of $M_{0}^{p, q}\left(\mathbf{R}^{n}\right)$.

We collect basic properties of $M_{s}^{p, q}\left(\mathbf{R}^{n}\right)$ in the following lemma:
LEmma 2.2. Let $1 \leq p, p_{1}, p_{2}, q, q_{1}, q_{2} \leq \infty$ and $s, s_{1}, s_{2} \in \mathbf{R}$. Then
(i) The space $M_{s}^{p, q}\left(\mathbf{R}^{n}\right)$ is a Banach space, and different windows define equivalent norms.
(ii) (Density and duality) If $p, q<\infty$, then $\mathcal{S}\left(\mathbf{R}^{n}\right)$ is dense in $M_{s}^{p, q}\left(\mathbf{R}^{n}\right)$ and $\left(M_{s}^{p, q}\left(\mathbf{R}^{n}\right)\right)^{\prime}=M_{-s}^{p^{\prime}, q^{\prime}}\left(\mathbf{R}^{n}\right)$.
(iii) If $p_{1} \leq p_{2}, q_{1} \leq q_{2}$ and $s_{1} \geq s_{2}$, then $M_{s_{1}}^{p_{1}, q_{1}}\left(\mathbf{R}^{n}\right) \hookrightarrow M_{s_{2}}^{p_{2}, q_{2}}\left(\mathbf{R}^{n}\right)$.
(iv) If $s>\frac{n}{q^{\prime}}$, or $q=1$ and $s \geq 0$, then $M_{s}^{p, q}\left(\mathbf{R}^{n}\right) \subset C\left(\mathbf{R}^{n}\right)$ and $M_{s}^{p, q}\left(\mathbf{R}^{n}\right)$ are multiplication algebra, i.e., we have

$$
\|f g\|_{M_{s}^{p, q}} \leq c\|f\|_{M_{s}^{p, q}}\|g\|_{M_{s}^{p, q}}, \quad f, g \in M_{s}^{p, q}\left(\mathbf{R}^{n}\right)
$$

for some $c \geq 1$.
(v) If $s \geq 0$, then there exists $C>0$ such that

$$
\left\|f_{\lambda}\right\|_{M_{s}^{\infty, 1}} \leq C\|f\|_{M_{s}^{\infty, 1}} \quad \forall f \in M_{s}^{\infty, 1}\left(\mathbf{R}^{n}\right)
$$

for all $0<\lambda \leq 1$, where $f_{\lambda}(x)=f(\lambda x)$.
$(i)-(v)$ are announced in [6, Theorem 3.2], [9, Section 6], [16], [35], [36] and summaries are given in [1, [7, [17, Chapter 11].

We also note that there is another characterization of the modulation spaces using BUPUs on the Fourier transform side (see [11], [13] or [37]): Assume that $\varphi \in \mathcal{S}\left(\mathbf{R}^{n}\right)$ satisfies

$$
\operatorname{supp} \varphi \subset[-1,1]^{n} \quad \text { and } \quad \sum_{k \in \mathbf{Z}^{n}} \varphi(\xi-k)=1 \quad \text { for all } \xi \in \mathbf{R}^{n}
$$

Then we have, writing $\varphi(D-k) f=\mathcal{F}^{-1}\left(T_{k} \varphi \cdot \widehat{f}\right)$ :

$$
\|f\|_{M_{s}^{p, q}} \approx\left(\sum_{k \in \mathbf{Z}^{n}}\langle k\rangle^{s q}\left(\int_{\mathbf{R}^{n}}|\varphi(D-k) f(x)|^{p} d x\right)^{\frac{q}{p}}\right)^{\frac{1}{q}}
$$

with obvious modifications if $p$ or $q=\infty$.
REmark 2.3. We note that we may assume that $0 \leq \varphi(\xi) \leq 1\left(\xi \in \mathbf{R}^{n}\right)$ and $\varphi(\xi)=1$ on the box $\left[-\frac{1}{10}, \frac{1}{10}\right]^{n}$.

Remark 2.4. Let $1 \leq q \leq \infty, s \in \mathbf{R}$ and $\left(B,\|\cdot\|_{B}\right)$ be a Banach space of tempered distributions on $\mathbf{R}^{n}$ such that $\mathcal{S} \cdot B \subset B$. Using BUPUs the Wiener amalgam space $W\left(B, \ell_{s}^{q}\right)\left(\mathbf{R}^{n}\right)$ is defined by the norm

$$
\|f\|_{W\left(B, \ell_{s}^{q}\right)}=\left(\sum_{k \in \mathbf{Z}^{n}}\langle k\rangle^{s q}\left\|f \cdot T_{k} \varphi\right\|_{B}^{q}\right)^{\frac{1}{q}}<\infty .
$$

We note that $W\left(\mathcal{F} L^{p}, \ell_{s}^{q}\right)\left(\mathbf{R}^{n}\right)=\mathcal{F}^{-1}\left(M_{s}^{p, q}\left(\mathbf{R}^{n}\right)\right)$, where $\mathcal{F} L^{p}\left(\mathbf{R}^{n}\right)(=$ $\mathcal{F} L^{p}$ ) denotes the Fourier-Lebesgue space with the norm $\|f\|_{\mathcal{F} L^{p}}=$ $\|\widehat{f}\|_{L^{p}}$ (see also Section 2.3 below).

The following lemma seems to be known to many people, but for the reader's convenience, we give the proof (cf. [13], [18] or [34]).
Lemma 2.5. Let $1 \leq p, q<\infty$. Suppose that $s>n / q^{\prime}$, or $q=1$ and $s \geq 0$. Then we have

$$
\|f g\|_{M_{s}^{p, q}} \lesssim\|f\|_{M_{s}^{\infty, q}}\|g\|_{M_{s}^{p, q}}, \quad f, g \in \mathcal{S}\left(\mathbf{R}^{n}\right)
$$

If $f \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ and $g \in M_{-s}^{p^{\prime}, \infty}\left(\mathbf{R}^{n}\right)$, then $f g \in M_{-s}^{1, \infty}\left(\mathbf{R}^{n}\right)\left(\hookrightarrow M_{-s}^{p^{\prime}, \infty}\left(\mathbf{R}^{n}\right)\right)$.
Proof. We start the proof by observing that the pointwise relationships for modulation spaces correspond to convolution relations for their (inverse) Fourier transforms in $W\left(\mathcal{F} L^{p}, \ell_{s}^{q}\right)\left(\mathbf{R}^{n}\right)$.

The claim made is thus equivalent to the statement that (writing $f, g$ for $\widehat{f}, \widehat{g}$ respectively):

$$
\begin{equation*}
\|f * g\|_{W\left(\mathcal{F} L^{p}, \ell_{s}^{q}\right)} \lesssim\|f\|_{W\left(\mathcal{F} L^{\infty}, \ell_{s}^{q}\right)}\|g\|_{W\left(\mathcal{F} L^{p}, \ell_{s}^{q}\right)} \tag{2}
\end{equation*}
$$

which results by the coordinate-wise convolution result established in [12] and the fact that

$$
\mathcal{F} L^{p} * \mathcal{F} L^{\infty} \subset \mathcal{F} L^{p} \quad \text { because } \quad L^{p} \cdot L^{\infty} \subseteq L^{p}
$$

as well as the fact that $\left(\ell_{s}^{q}\left(\mathbf{Z}^{n}\right),\|\cdot\|_{\ell_{s}^{q}}\right)$ is a Banach algebra with respect to the natural convolution, because the weight function $x \mapsto\langle x\rangle^{s}$ is weakly subadditive for any $s \geq 0$ and consequently $\ell^{1}\left(\mathbf{Z}^{n}\right) \cap \ell_{s}^{q}\left(\mathbf{Z}^{n}\right)$ is a Banach algebra with respect to convolution. This observation have been made explicit in [4]. But for $s>\frac{n}{q^{\prime}}$, it follows from the Hölder inequality that $\ell_{s}^{q}\left(\mathbf{Z}^{n}\right) \hookrightarrow \ell^{1}\left(\mathbf{Z}^{n}\right)$ (with corresponding continuous embedding), and thus $\left(\ell_{s}^{q}\left(\mathbf{Z}^{n}\right),\|\cdot\|_{\ell_{s}^{q}}\right)$ is Banach algebra with respect to (discrete) convolution.

In a similar way we use the local convolution relation

$$
\mathcal{F} L^{p} * \mathcal{F} L^{p^{\prime}} \subset \mathcal{F} L^{\infty} \quad \text { due to the relation } \quad L^{p} \cdot L^{p^{\prime}} \subseteq L^{\infty},
$$

combined with the global condition

$$
\ell_{s}^{p} * \ell_{-s}^{p^{\prime}} \subseteq \ell_{-s}^{\infty}
$$

using the submultiplicativity condition (writing $x=(x-y)+y$ ):

$$
\langle x+y\rangle^{-s} \leq\langle x\rangle^{-s}\langle y\rangle^{s} .
$$

Let us also observe another consequence of the reasoning used in the last proof, which allows to provide some insight into the pointwise multiplier algebra of Sobolev algebras. We formulate it as another lemma. Let us shortly recall that the classical Sobolev spaces $\left(H^{s}\left(\mathbf{R}^{n}\right),\|\cdot\|_{H^{s}}\right)$ are just inverse images of (polynomially) weighted $L^{2}$-spaces, and thus appear in the family of modulation spaces as

$$
H^{s}=\mathcal{F}^{-1}\left(L_{s}^{2}\right)=\mathcal{F}^{-1}\left(W\left(\mathcal{F}^{-1}\left(L^{2}\right), \ell_{s}^{2}\right)\right)=\mathcal{F}^{-1}\left(W\left(L^{2}, \ell_{s}^{2}\right)\right)
$$

so that one has $\ell_{s}^{2}\left(\mathbf{Z}^{n}\right) \hookrightarrow \ell^{1}\left(\mathbf{Z}^{n}\right)$ for $s>\frac{n}{2}$ via the Cauchy-Schwarz inequality and consequently by the Hausdorff-Young version for Wiener amalgams (see [10]) one has the following chain of continuous embeddings:

$$
H^{s} \hookrightarrow \mathcal{F}^{-1}\left(W\left(L^{2}, \ell^{1}\right)\right) \hookrightarrow W\left(\mathcal{F} L^{1}, \ell^{2}\right) \hookrightarrow W\left(C_{0}, \ell^{2}\right) .
$$

Lemma 2.6. For $s>n / 2$ we have $M_{s}^{\infty, 2} \cdot H^{s} \subseteq H^{s}$, meaning that $M_{s}^{\infty, 2}\left(\mathbf{R}^{n}\right)$ is a subset of the pointwise multiplier algebra of the Sobolev algebra $H^{s}\left(\mathbf{R}^{n}\right)$.

Proof. We have already noted that $s>n / 2$ implies $H^{s}\left(\mathbf{R}^{n}\right) \hookrightarrow$ $W\left(C_{0}, \ell^{2}\right)\left(\mathbf{R}^{n}\right)$. The following reasoning implies the classical fact that it is a Banach algebra with respect to pointwise multiplication (denoted as Sobolev algebra).

We have to verify that the corresponding convolution relation is valid on the Fourier transform side. In fact, we may invoke the main result of [12]:

$$
\begin{equation*}
W\left(\mathcal{F} L^{\infty}, \ell_{s}^{2}\right) * W\left(\mathcal{F} L^{2}, \ell_{s}^{2}\right) \subset W\left(L^{2}, \ell_{s}^{2}\right) \tag{3}
\end{equation*}
$$

using again that $\ell_{s}^{2}\left(\mathbf{Z}^{n}\right)=\ell_{s}^{2}\left(\mathbf{Z}^{n}\right) \cap \ell^{1}\left(\mathbf{Z}^{n}\right)$ is a Banach algebra with respect to convolution, and

$$
\mathcal{F} L^{\infty} * \mathcal{F} L^{2} \subseteq \mathcal{F} L^{2}=L^{2}, \quad \text { due to the fact that } L^{\infty} \cdot L^{2} \subseteq L^{2}
$$

In order to make our paper self-contained let us recall the following result which makes use of elementary inclusion results for Wiener amalgams and the Hausdorff-Young theorem for generalized amalgam spaces as described in [13, Theorem 9]. It states (in the unweighted version) that one has

$$
\mathcal{F}\left(W\left(\mathcal{F} L^{p}, \ell^{q}\right)\right) \hookrightarrow W\left(\mathcal{F} L^{q}, \ell^{p}\right) \quad \text { for } 1 \leq q \leq p \leq \infty .
$$

In particular it implies the Fourier invariance of the space $W\left(\mathcal{F} L^{p}, \ell^{p}\right)$, for $1 \leq p \leq \infty$ (the unweighted version of Theorem 6 of [13]).

Lemma 2.7. For $1 \leq p \leq 2$ we have the chain of continuous embeddings

$$
W\left(\mathcal{F} L^{p}, \ell^{p}\right) \hookrightarrow \mathcal{F} L^{p} \hookrightarrow W\left(\mathcal{F} L^{p}, \ell^{p^{\prime}}\right)
$$

or by taking inverse Fourier transforms

$$
M^{p, p}\left(\mathbf{R}^{n}\right) \hookrightarrow L^{p}\left(\mathbf{R}^{n}\right) \hookrightarrow M^{p, p^{\prime}}\left(\mathbf{R}^{n}\right)
$$

In particular, we have $M^{2,2}\left(\mathbf{R}^{n}\right)=L^{2}\left(\mathbf{R}^{n}\right)$.
Proof. We start with the observation that the classical HausdorffYoung estimate implies for $1 \leq p \leq 2$, with $1 / p^{\prime}+1 / p=1$ :

$$
\mathcal{F} L^{p} \hookrightarrow L^{p^{\prime}} \quad \text { or equivalently } \quad L^{p} \hookrightarrow \mathcal{F} L^{p^{\prime}}
$$

and consequently

$$
W\left(\mathcal{F} L^{p}, \ell^{p}\right) \hookrightarrow W\left(L^{p^{\prime}}, \ell^{p}\right) \hookrightarrow W\left(L^{p}, \ell^{p}\right)=L^{p}
$$

which implies:

$$
W\left(\mathcal{F} L^{p}, \ell^{p}\right)=\mathcal{F}\left(W\left(\mathcal{F} L^{p}, \ell^{p}\right)\right) \hookrightarrow \mathcal{F} L^{p}, \quad \text { for } 1 \leq p \leq 2 .
$$

Thus the first continuous embeddings is verified. For the second inclusion recall that [13]) (see above, due to the obvious fact that $p \leq 2 \leq p^{\prime}$ ) implies

$$
\mathcal{F} L^{p}=\mathcal{F}\left(W\left(L^{p}, \ell^{p}\right)\right) \hookrightarrow \mathcal{F}\left(W\left(\mathcal{F} L^{p^{\prime}}, \ell^{p}\right)\right) \hookrightarrow_{H Y} W\left(\mathcal{F} L^{p}, \ell^{p^{\prime}}\right)
$$

2.3. Fourier-Beurling algebra. For $s \geq 0$ the Fourier-Beurling algebra $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)=\mathcal{F} L_{s}^{1}$ is the set of all $f \in \mathcal{S}^{\prime}\left(\mathbf{R}^{n}\right)$ such that the norm

$$
\|f\|_{\mathcal{F} L_{s}^{1}}=\int_{\mathbf{R}^{n}}\langle\xi\rangle^{s}|\widehat{f}(\xi)| d \xi
$$

is finite. It is well-known that $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$ is a multiplication algebra, because Beurling algebras are Banach convolution algebras (31). We also recall the following result (e.g., [31, Proposition 1.6.14]):

Lemma 2.8. Let $s \geq 0$ and $f \in \mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$. Then for any $\varepsilon>0$, there exists $\phi \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ such that $\|f-\phi f\|_{\mathcal{F}_{s}^{1}}<\varepsilon$.

For the inclusion relation between $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$ and $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, we have the following (cf. [28], [29]).

Lemma 2.9. For $1 \leq p \leq 2$ and $s \geq 0$ one has $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right) \hookrightarrow \mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$.
Proof. Let $f \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ and $\varphi \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ be such that $\operatorname{supp} \varphi \subset$ $[-1,1]^{n}$ and $\sum_{k \in \mathbf{Z}^{n}} \varphi(\xi-k)=1$. Since $\operatorname{supp} \varphi(\cdot-k) \subset k+[-1,1]^{n}$, it follows from the Minkowski inequality for integral, the Hölder inequality and the Hausdorff-Young inequality that

$$
\begin{aligned}
\|f\|_{\mathcal{F} L_{s}^{1}} & \leq\left\|\sum_{k \in \mathbf{Z}^{n}}\langle\cdot\rangle^{s}|\varphi(\cdot-k) \widehat{f}(\cdot)|\right\|_{L^{1}} \lesssim \sum_{k \in \mathbf{Z}^{n}}\langle k\rangle^{s}\|\varphi(\cdot-k) \widehat{f}(\cdot)\|_{L^{1}} \\
& \lesssim \sum_{k \in \mathbf{Z}^{n}}\langle k\rangle^{s}\|\varphi(\cdot-k) \widehat{f}(\cdot)\|_{L^{p^{\prime}}} \lesssim \sum_{k \in \mathbf{Z}^{n}}\langle k\rangle^{s}\|\varphi(D-k) f\|_{L^{p}}=\|f\|_{M_{s}^{p, 1}},
\end{aligned}
$$

which yields the desired result.
Lemma 2.10. For $s \geq 0$ we define the space $\left(\mathcal{F} L_{s}^{1}\right)_{c}$ by

$$
\left(\mathcal{F} L_{s}^{1}\right)_{c}=\left\{f \in \mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right) \mid \operatorname{supp} f \text { is compact }\right\} .
$$

Then we have $\left(\mathcal{F} L_{s}^{1}\right)_{c} \hookrightarrow M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ for $1 \leq p<\infty$.
Proof. Let $f \in \mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$ and supp $f$ be compact. Then for $\phi \in$ $\mathcal{S}\left(\mathbf{R}^{n}\right)$ with $\phi(x)=1$ on supp $f$, we have by Lemma 2.5

$$
\|f\|_{M_{s}^{p, 1}}=\|f \phi\|_{M_{s}^{p, 1}} \lesssim\|f\|_{M_{s}^{\infty, 1}}\|\phi\|_{M_{s}^{p, 1}} .
$$

Moreover, for $\varphi \in \mathcal{S}\left(\mathbf{R}^{n}\right)$ with $\sum_{k \in \mathbf{Z}^{n}} \varphi(\xi-k)=1$, we have that

$$
\|f\|_{M_{s}^{\infty, 1}}=\sum_{k \in \mathbf{Z}^{n}}\langle k\rangle^{s}\|\varphi(D-k) f\|_{L^{\infty}} \lesssim \sum_{k \in \mathbf{Z}^{n}}\langle k\rangle^{s}\|\varphi(\cdot-k) \widehat{f}\|_{L^{1}} \lesssim\|f\|_{\mathcal{F} L_{s}^{1}},
$$

which implies the desired result.

## 3. Approximate units

In this section, we prove the following result, which corresponds to the $M_{s}^{p, q}$-version of Bhimani-Ratnakumar [3, Proposition 3.14].

Lemma 3.1. Given $1 \leq p, q<\infty$ and $s>n / q^{\prime}$, or $q=1$ and $s \geq 0$. Then for any $f \in M_{s}^{p, q}\left(\mathbf{R}^{n}\right)$, and $\varepsilon>0$ there exists $\phi \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ such that

$$
\|f-\phi f\|_{M_{s}^{p, q}}<\varepsilon .
$$

We remark that Bhimani [2, Proposition 4.8] considers the case $q=1$ and $s=0$.
3.1. Technical lemmas. To prove Theorem 3.1 we prepare a lemma.

Lemma 3.2. Let $s \geq 0$ and $\psi \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ be such that $\psi(0)=1$. For $0<\lambda<1$, we define $\psi_{\lambda}(x)=\psi(\lambda x)$. Then, for any $g \in \mathcal{S}\left(\mathbf{R}^{n}\right)$ and $\varepsilon>0$, there exists $0<\lambda_{0}<1$ such that

$$
\left\|\left(1-\psi_{\lambda}\right) g\right\|_{M_{s}^{1,1}}<\varepsilon \quad \forall 0<\lambda<\lambda_{0} .
$$

Proof. Let $\phi \in \mathcal{S}\left(\mathbf{R}^{n}\right) \backslash\{0\}$. We first note that

$$
V_{\phi}\left(\left(1-\psi_{\lambda}\right) g\right)(x, \xi)=(2 \pi)^{-n} e^{-i x \xi} V_{\widehat{\phi}}\left(\widehat{g}-(2 \pi)^{-n}\left(\widehat{\psi_{\lambda}} * \widehat{g}\right)\right)(\xi,-x)
$$

by (11) in Section 2.1. Moreover, since $\widehat{\psi_{\lambda}}(\eta)=\frac{1}{\lambda^{n}} \widehat{\psi}\left(\frac{\eta}{\lambda}\right)$ and $1=\psi(0)=$ $\frac{1}{(2 \pi)^{n}} \int_{\mathbf{R}^{n}} \widehat{\psi_{\lambda}}(\eta) d \eta$, we have

$$
\begin{aligned}
\widehat{g}(t)-(2 \pi)^{-n}\left(\widehat{\psi_{\lambda}} * \widehat{g}\right)(t) & =\frac{1}{(2 \pi \lambda)^{n}} \int_{\mathbf{R}^{n}}(\widehat{g}(t)-\widehat{g}(t-\eta)) \widehat{\psi}\left(\frac{\eta}{\lambda}\right) d \eta \\
& =\frac{1}{(2 \pi)^{n}} \int_{\mathbf{R}^{n}}\left(\widehat{g}(t)-\left(T_{\lambda \eta} \widehat{g}\right)(t)\right) \widehat{\psi}(\eta) d \eta
\end{aligned}
$$

and thus
$V_{\widehat{\phi}}\left(\widehat{g}-(2 \pi)^{-n}\left(\widehat{\psi_{\lambda}} * \widehat{g}\right)\right)(\xi,-x)=\frac{1}{(2 \pi)^{2 n}} \int_{\mathbf{R}^{n}} V_{\widehat{\phi}}\left(\widehat{g}-T_{\lambda \eta} \widehat{g}\right)(\xi,-x) \widehat{\psi}(\eta) d \eta$.
Therefore we obtain by the Fubini Theorem that

$$
\begin{aligned}
\left\|\left(1-\psi_{\lambda}\right) g\right\|_{M_{s}^{1,1}} & \approx \iint_{\mathbf{R}^{2 n}}\langle\xi\rangle^{s}\left|V_{\widehat{\phi}}\left(\widehat{g}-(2 \pi)^{-n}\left(\widehat{\psi_{\lambda}} * \widehat{g}\right)\right)(\xi,-x)\right| d x d \xi \\
& \lesssim \int_{\mathbf{R}^{n}}\left\|\langle\xi\rangle^{s} V_{\widehat{\phi}}\left(\widehat{g}-T_{\lambda \eta} \widehat{g}\right)(\xi,-x)\right\|_{L^{1}\left(\mathbf{R}_{(x, \xi)}^{2 n}\right)}|\widehat{\psi}(\eta)| d \eta
\end{aligned}
$$

On the other hand, since $0<\lambda<1, s \geq 0$ and

$$
V_{\widehat{\phi}}\left(T_{\lambda \eta} \widehat{g}\right)(\xi,-x)=e^{-i \lambda \eta(-x)}\left(V_{\widehat{\phi}} \widehat{g}\right)(\xi-\lambda \eta,-x),
$$

we have

$$
\begin{aligned}
& \left\|\langle\xi\rangle^{s} V_{\widehat{\phi}}\left(\widehat{g}-T_{\lambda \eta} \widehat{g}\right)(\xi,-x)\right\|_{L^{1}\left(\mathbf{R}_{(x, \xi)}^{2 n}\right)} \\
& \lesssim \iint_{\mathbf{R}^{2 n}}\langle\xi\rangle^{s}\left|V_{\widehat{\phi}} \widehat{g}(\xi,-x)\right| d x d \xi+\langle\lambda \eta\rangle^{s} \iint_{\mathbf{R}^{2 n}}\langle\xi-\lambda \eta\rangle^{s}\left|V_{\widehat{\phi}} \widehat{g}(\xi-\lambda \eta,-x)\right| d x d \xi \\
& \lesssim\langle\eta\rangle^{s}\left\|\langle\xi\rangle^{s} V_{\widehat{\phi}} \widehat{g}(\xi,-x)\right\|_{L^{1}\left(\mathbf{R}_{(x, \xi)}^{2 n}\right)} .
\end{aligned}
$$

We note that since $\widehat{\phi}, \widehat{g} \in \mathcal{S}\left(\mathbf{R}^{n}\right)$, we have $V_{\widehat{\phi}} \widehat{g} \in \mathcal{S}\left(\mathbf{R}^{2 n}\right)$, and also
$V_{\widehat{\phi}}\left(\widehat{g}-T_{\lambda \eta} \widehat{g}\right)(\xi,-x)=\int_{\mathbf{R}^{n}}(\widehat{g}(t)-\widehat{g}(t-\lambda \eta)) \overline{\widehat{\phi}(t-\xi)} e^{i x t} d t \rightarrow 0 \quad(\lambda \rightarrow 0)$
for all $\eta, \xi, x \in \mathbf{R}^{n}$. Thus it follows from the Lebesgue convergence theorem that

$$
\left\|\left(1-\psi_{\lambda}\right) g\right\|_{M_{s}^{1,1}} \lesssim \iiint_{\mathbf{R}^{3 n}}\langle\xi\rangle^{s}\left|V_{\widehat{\phi}}\left(\widehat{g}-T_{\lambda \eta} \widehat{g}\right)(\xi,-x) \| \widehat{\psi}(\eta)\right| d x d \xi d \eta \rightarrow 0
$$

as $\lambda \rightarrow 0$, which implies the desired result.
3.2. The proof of Theorem 3.1. Let $\varepsilon>0$. Since $\mathcal{S}\left(\mathbf{R}^{n}\right)$ is dense in $M_{s}^{p, q}\left(\mathbf{R}^{n}\right)$, there exists $g \in \mathcal{S}\left(\mathbf{R}^{n}\right)$ such that $\|f-g\|_{M_{s}^{p, q}}<\varepsilon$. Moreover by Lemma 3.2, there exist $\psi \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ and $0<\lambda_{0}<1$ such that $\left\|\left(1-\psi_{\lambda}\right) g\right\|_{M_{s}^{1,1}}<\varepsilon$ for all $0<\lambda<\lambda_{0}$, where $\psi_{\lambda}(x)=\psi(\lambda x)$. Thus we have by Lemma 2.2 (v) and Lemma 2.5 that

$$
\begin{aligned}
\left\|f-\psi_{\lambda} f\right\|_{M_{s}^{p, q}} & \lesssim\|f-g\|_{M_{s}^{p, q}}+\left\|\psi_{\lambda}(f-g)\right\|_{M_{s}^{p, q}}+\left\|\left(1-\psi_{\lambda}\right) g\right\|_{M_{s}^{p, q}} \\
& \lesssim\left(1+\left\|\psi_{\lambda}\right\|_{M_{s}^{\infty, q}}\right)\|f-g\|_{M_{s}^{p, q}}+\left\|\left(1-\psi_{\lambda}\right) g\right\|_{M_{s}^{p, q}} \\
& \lesssim\left(1+\left\|\psi_{\lambda}\right\|_{M_{s}^{\infty, 1}}\right)\|f-g\|_{M_{s}^{p, q}}+\left\|\left(1-\psi_{\lambda}\right) g\right\|_{M_{s}^{1,1}} \\
& \leq\left(2+C\|\psi\|_{M_{s}^{\infty, 1}}\right) \varepsilon,
\end{aligned}
$$

which implies the desired result.

## 4. Closed ideals in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$

In this section, we consider the closed ideals in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, which play an important role in Section 6. Throughout this section, $X$ stands for $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)(1 \leq p<\infty, s \geq 0)$ or $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)(s \geq 0)$.

Definition 4.1. Let $I$ be a linear subspace of $X$. Then $I$ is called an ideal in $X$ if $f g \in I$ whenever $f \in X$ and $g \in I$. Moreover, if an ideal $I$ in $X$ is a closed subset of $X$, then $I$ is called a closed ideal in $X$. For a subset $S$ of $X$, the set $\bigcap_{\lambda \in \Lambda} I_{\lambda}$ is called the ideal generated by $S$, where $\left\{I_{\lambda}\right\}_{\lambda \in \Lambda}$ denoted the set of all ideals in $X$ containing $S$.

It is easy to see that the closed ideal generated by $S$ coincides with the closure in $X$ of the set

$$
\left\{\sum_{j=1}^{n} f_{j} g_{j} \mid f_{j} \in X, g_{j} \in S, n \in \mathbf{N}\right\} .
$$

Definition 4.2. For a closed ideal $I$ of $X$ the zero-set of $I$ is defined by $Z(I)=\bigcap_{f \in I} f^{-1}(\{0\})$ with $f^{-1}(\{0\})=\left\{x \in \mathbf{R}^{2} \mid f(x)=0\right\}$.

We note that $x \in Z(I)$ if and only if $f(x)=0$ for all $f \in I$. Moreover, $Z(I)$ is a closed subset of $X$ whenever $I$ is a closed ideal in $X$. In fact, if $f \in X$, then $f$ is continuous on $\mathbf{R}^{n}$ and thus $f^{-1}(\{0\})$ is a closed subset of $\mathbf{R}^{n}$.

The following lemma seems to be known to many people, but for the reader's convenience, we give the proof. We will write $\left.f\right|_{E}=0$ if $f(x)=0$ for all $x \in E$.

Lemma 4.3. Let $E$ be a closed subset of $\mathbf{R}^{n}$. Then

$$
I(E)=\left\{f \in X|f|_{E}=0\right\}
$$

is a closed ideal in $X$ with $E=Z(I(E))$.
Proof. We give the proof only for the case $X=M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$; the other case is similar. It is clear that $I(E)$ is an ideal in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. To see that $I(E)$ is closed, let $f \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right),\left\{f_{n}\right\}_{n=1}^{\infty} \subset I(E)$ and $\left\|f_{n}-f\right\|_{M_{s}^{p, 1}} \rightarrow 0$ $(n \rightarrow \infty)$. Since

$$
\left\|f_{n}-f\right\|_{L^{\infty}} \lesssim\left\|f_{n}-f\right\|_{M^{\infty, 1}} \lesssim\left\|f_{n}-f\right\|_{M^{p, 1}} \lesssim\left\|f_{n}-f\right\|_{M_{s}^{p, 1}}
$$

we see that $\left\{f_{n}\right\}_{n=1}^{\infty}$ converges pointwise to $f$ on $\mathbf{R}^{n}$. Since $\left.f_{n}\right|_{E}=0$, we have $\left.f\right|_{E}=0$, and thus $f \in I(E)$. Hence $I(E)$ is closed. Next we prove $E=Z(I(E))$. Since $E \subset Z(I(E))$ is clear, we show $Z(I(E)) \subset E$. Suppose $x_{0} \notin E$. Since $E$ is closed and $C_{c}^{\infty}\left(\mathbf{R}^{n}\right) \subset M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, there exists $f \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ such that $f\left(x_{0}\right)=1$ and $\left.f\right|_{E}=0$. Then $f \in$ $I(E)$ and $f\left(x_{0}\right) \neq 0$. Thus $x_{0} \notin Z(I(E))$, which implies the desired result.

We also prepare the following lemma, which also characterises closed ideals in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. We will call a subspace $M$ of $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ is modulation invariant if $M_{\eta} f(x)=e^{i x \eta} f(x) \in M$ whenever $f \in M$ and $\eta \in \mathbf{R}^{n}$.

Lemma 4.4. Given $1 \leq p<\infty$ and $s \geq 0$.
Then for any closed ideal I in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, one has:
(i) If $g \in M_{-s}^{p^{\prime}, \infty}\left(\mathbf{R}^{n}\right)$ satisfies

$$
\begin{equation*}
\iint_{\mathbf{R}^{2 n}} V_{\phi} f(x, \xi) \overline{V_{\psi} g(x, \xi)} d x d \xi=0 \quad \text { for all } f \in I \tag{4}
\end{equation*}
$$

for any pair $\phi, \psi \in \mathcal{S}\left(\mathbf{R}^{n}\right)$ with $\langle\psi, \phi\rangle \neq 0$, if and only if

$$
\begin{equation*}
\int_{\mathbf{R}^{n}}\left[V_{\phi} f(x, \cdot) * V_{\bar{\psi}} \bar{g}(x, \cdot)\right](\xi) d x=0 \quad \text { for all } f \in I, \xi \in \mathbf{R}^{n} \tag{5}
\end{equation*}
$$

for any pair $\phi, \psi \in \mathcal{S}\left(\mathbf{R}^{n}\right)$ with $\langle\psi, \phi\rangle \neq 0$.
(ii) Every closed ideal in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ coincides with a closed modulation invariant subspace of $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$.

Proof. We first assume that (5) holds. Then we have

$$
0=\int_{\mathbf{R}^{n}}\left[V_{\phi} f(x, \cdot) * V_{\bar{\psi}} \bar{g}(x, \cdot)\right](\xi) d x=(2 \pi)^{n}\langle\psi, \phi\rangle\left\langle M_{-\xi} f, g\right\rangle
$$

for all $f \in I, \xi \in \mathbf{R}^{n}$ and $\phi, \psi \in \mathcal{S}\left(\mathbf{R}^{n}\right)$ with $\langle\psi, \phi\rangle \neq 0$, and thus $\langle f, g\rangle=0$. Hence

$$
\iint_{\mathbf{R}^{2 n}} V_{\phi} f(x, \xi) \overline{V_{\psi} g(x, \xi)} d x d \xi=(2 \pi)^{-n}\langle\psi, \phi\rangle\langle f, g\rangle=0,
$$

which gives (4).
Next we assume that (4) holds. We note that Lemma 2.5 implies that $f \bar{g} \in M_{-s}^{1, \infty}\left(\mathbf{R}^{n}\right) \hookrightarrow M_{-s}^{p^{\prime}, \infty}\left(\mathbf{R}^{n}\right)$ for all $f \in I$. Then for all $h \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ and $\phi, \psi \in \mathcal{S}\left(\mathbf{R}^{n}\right)$ with $\langle\psi, \phi\rangle \neq 0$, we have

$$
\langle\psi, \phi\rangle\langle f \bar{g}, h\rangle=\langle\psi, \phi\rangle\langle f \bar{h}, g\rangle=(2 \pi)^{-n}\left\langle V_{\phi}(f \bar{h}), V_{\psi} g\right\rangle .
$$

On the other hand, since $f \in I$ and $I$ is a closed ideal in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, we see that $f \bar{h} \in I$. Therefore, (44) implies that $\left\langle V_{\phi}(f \bar{h}), V_{\psi} g\right\rangle=0$, and thus $\langle f \bar{g}, h\rangle=0$. By the duality, we obtain $f \bar{g}=0$. Hence, we obtain for $x, \xi \in \mathbf{R}^{n}$ that

$$
\begin{aligned}
0 & =V_{\phi \bar{\psi}}(f \bar{g})(x, \xi) \\
& =(2 \pi)^{-n} \int_{\mathbf{R}^{n}} V_{\phi} f(x, \xi-\eta) V_{\bar{\psi}} \bar{g}(x, \eta) d \eta \\
& =(2 \pi)^{-n} \int_{\mathbf{R}^{n}} V_{\phi}\left(M_{-\xi} f\right)(x,-\eta) \overline{V_{\psi} g(x,-\eta)} d \eta
\end{aligned}
$$

and thus $\langle\psi, \phi\rangle\left\langle M_{-\xi} f, g\right\rangle=0$, which implies (5).
Finally, we give the characterization of closed ideals in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. Let $I$ be a closed ideal in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. We first note that if $g \in M_{-s}^{p^{\prime}, \infty}\left(\mathbf{R}^{n}\right)$
satisfies (5), then

$$
\begin{equation*}
0=\int_{\mathbf{R}^{n}}\left[V_{\phi} f(x, \cdot) * V_{\bar{\psi}} \bar{g}(x, \cdot)\right](\xi) d x=\left\langle V_{\phi}\left(M_{-\xi} f\right), V_{\psi} g\right\rangle \tag{6}
\end{equation*}
$$

holds for all $f \in I, \xi \in \mathbf{R}^{n}$ and $\phi, \psi \in \mathcal{S}\left(\mathbf{R}^{n}\right)$ with $\langle\psi, \phi\rangle \neq 0$. Suppose that $I$ is not modulation invariant. Then there exist $f_{0} \in I$ and $\eta_{0} \in \mathbf{R}^{n}$ such that $M_{-\eta_{0}} f_{0} \notin I$. On the other hand, we note that $\left(M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)\right)^{\prime}=M_{-s}^{p^{\prime}, \infty}\left(\mathbf{R}^{n}\right)$, i.e., for any $\ell \in\left(M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)\right)^{\prime}$ and $\phi, \psi \in \mathcal{S}\left(\mathbf{R}^{n}\right)$ with $\langle\psi, \phi\rangle=0$, there exists $g \in M_{-s}^{p^{\prime}, \infty}\left(\mathbf{R}^{n}\right)$ such that

$$
\ell(f)=\frac{1}{(2 \pi)^{n}\langle\psi, \phi\rangle}\left\langle V_{\phi} f, V_{\psi} g\right\rangle .
$$

Therefore, the Hahn-Banach theorem and the duality imply that there exists $g_{0} \in M_{-s}^{p^{\prime}, \infty}\left(\mathbf{R}^{n}\right)$ such that

$$
\left\langle f, g_{0}\right\rangle=\frac{1}{(2 \pi)^{n}\langle\psi, \phi\rangle}\left\langle V_{\phi} f, V_{\psi} g_{0}\right\rangle=0
$$

for all $f \in I$, and

$$
\left\langle M_{-\eta} f, g_{0}\right\rangle=\frac{1}{(2 \pi)^{n}\langle\psi, \phi\rangle}\left\langle V_{\phi}\left(M_{-\eta} f_{0}\right), V_{\psi} g_{0}\right\rangle=1 .
$$

The above two equalities imply that $g_{0}$ satisfies (5) but not (6), which yields a contradiction.

Conversely, we assume that $I$ is a closed modulation invariant subspace of $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. If $I$ is not an ideal in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, then there exist $f_{0} \in I$ and $h_{0} \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ such that $f_{0} \overline{h_{0}} \notin I$. The Hahn-Banach theorem and the duality imply that there exists $g_{0} \in M_{-s}^{p^{\prime}, \infty}\left(\mathbf{R}^{n}\right)$ such that

$$
\begin{equation*}
\left\langle f, g_{0}\right\rangle=\frac{1}{(2 \pi)^{n}\langle\psi, \phi \bar{\phi}\rangle}\left\langle V_{\phi \bar{\phi}} f, V_{\psi} g_{0}\right\rangle=0 \tag{7}
\end{equation*}
$$

for all $f \in I$, and

$$
\begin{equation*}
\left\langle f_{0} \overline{h_{0}}, g_{0}\right\rangle=\frac{1}{(2 \pi)^{n}\langle\psi, \phi \bar{\phi}\rangle}\left\langle V_{\phi \bar{\phi}}\left(f_{0} \overline{h_{0}}\right), V_{\psi} g_{0}\right\rangle=1 . \tag{8}
\end{equation*}
$$

We note that

$$
V_{\phi \bar{\phi}}\left(f_{0} \overline{h_{0}}\right)(x, \xi)=(2 \pi)^{-n}\left[V_{\phi} f_{0}(x, \cdot) * V_{\bar{\phi}} \overline{h_{0}}(x, \cdot)\right](\xi)
$$

and thus

$$
\begin{aligned}
\left\langle V_{\phi \bar{\phi}}\left(f_{0} \overline{h_{0}}\right), V_{\psi} g_{0}\right\rangle & =(2 \pi)^{-n} \int_{\mathbf{R}^{n}}\left[\left(V_{\phi} f_{0}(x, \cdot) * V_{\bar{\phi}} \overline{h_{0}}(x, \cdot)\right) * V_{\bar{\psi}} \overline{g_{0}}(x, \cdot)\right](0) d x \\
& =(2 \pi)^{-n} \int_{\mathbf{R}^{n}}\left[\left(V_{\phi} f_{0}(x, \cdot) * V_{\bar{\psi}} \overline{g_{0}}(x, \cdot)\right) * V_{\bar{\phi}}^{\overline{h_{0}}}(x, \cdot)\right](0) d x .
\end{aligned}
$$

Moreover for all $x, \xi \in \mathbf{R}^{n}$, we have by the Parseval identity that

$$
\begin{aligned}
& {\left[V_{\phi} f_{0}(x, \cdot) * V_{\bar{\psi}} \overline{g_{0}}(x, \cdot)\right](\xi)} \\
& =\int_{\mathbf{R}^{n}} V_{\phi}\left(M_{-\xi} f_{0}\right)(x, \eta) \overline{V_{\psi} g_{0}(x, \eta)} d \eta \\
& =\int_{\mathbf{R}^{n}} \mathcal{F}_{y \rightarrow \eta}\left[\left(M_{-\xi} f_{0}\right)(y) \cdot \overline{\phi(y-x)}\right](\eta) \overline{\mathcal{F}_{y \rightarrow \eta}\left[g_{0}(y) \overline{\psi(y-x)}\right](\eta)} d \eta \\
& =(2 \pi)^{n} \int_{\mathbf{R}^{n}}\left(M_{-\xi} f_{0}\right)(y) \cdot \overline{\phi(y-x)} \overline{g_{0}(y) \overline{\psi(y-x)}} d y \\
& =\left\langle M_{-\xi} f_{0} \cdot T_{x}(\bar{\phi} \psi), g_{0}\right\rangle .
\end{aligned}
$$

Since $I$ is modulation invariant, we have $M_{-\xi} f_{0} \in I$, and thus $M_{-\xi} f_{0}$. $T_{x}(\bar{\phi} \psi) \in I$ by $T_{x}(\bar{\phi} \psi) \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. Therefore we have by (7)

$$
\left[V_{\phi} f_{0}(x, \cdot) * V_{\bar{\psi}} \overline{g_{0}}(x, \cdot)\right](\xi)=0
$$

Hence $\left\langle V_{\phi \bar{\phi}}\left(f_{0} \overline{h_{0}}\right), V_{\psi} g_{0}\right\rangle=0$, which contradicts (8).

## 5. Wiener-Lévy theorem for $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$

In this section, we consider the Wiener-Lévy theorem for $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ (cf. [31, Theorem 1.3.1]). More precisely, we show the following result.

Theorem 5.1. Given $1 \leq p<\infty, s \geq 0, f \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ and a compact subset $K \subset \mathbf{R}^{n}$. Suppose that $F$ is an analytic function on a neighborhood of $f(K)=\{f(x) \mid x \in K\}$ in $\mathbf{C}$. Then there exists $g \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ such that $g(x)=F(f(x))$ for all $x \in K$.

To prove Theorem 5.1, we prepare the following lemmas.
Lemma 5.2. Let $s \geq 0, f, h \in M_{s}^{1,1}\left(\mathbf{R}^{n}\right)$ and $x_{0} \in \mathbf{R}^{n}$. We set

$$
H_{x_{0}}^{\lambda}(x)=\left(f\left(x_{0}+\frac{x}{\lambda}\right)-f\left(x_{0}\right)\right) h(x), \quad \text { for } \lambda>0
$$

Then we have

$$
\begin{equation*}
\lim _{\lambda \rightarrow \infty}\left\|H_{x_{0}}^{\lambda}\right\|_{M_{s}^{1,1}}=0 \tag{9}
\end{equation*}
$$

Proof. With $g_{0}(t)=e^{-\frac{|t|^{2}}{2}}$ we have by (1) in Section 2.1 for $\lambda>1$

$$
\begin{aligned}
V_{g_{0}}\left(H_{x_{0}}^{\lambda}\right)(x, \xi) & =(2 \pi)^{-n} e^{i x \xi} V_{\widehat{g_{0}}}\left(H_{x_{0}}^{\lambda}\right)^{\wedge}(\xi,-x) \\
& =(2 \pi)^{-n}\left(\left(H_{x_{0}}^{\lambda}\right)^{\wedge} * M_{-x}\left(\widehat{g_{0}}\right)^{*}\right)(\xi) \\
& =(2 \pi)^{-\frac{n}{2}}\left(\left(H_{x_{0}}^{\lambda}\right)^{\wedge} * M_{-x} \widehat{g_{0}}\right)(\xi) .
\end{aligned}
$$

We note that

$$
\left(f\left(x_{0}+\dot{\bar{\lambda}}\right)\right)^{\wedge}(\eta)=\left(T_{\lambda x_{0}} D_{\lambda} f\right)^{\wedge}(\eta)=\lambda^{n} e^{i \lambda x_{0} \eta} \widehat{f}(\lambda \eta)
$$

with $D_{\lambda} f(\eta)=f\left(\frac{\eta}{\lambda}\right)$. Moreover, since $f, \widehat{f} \in M^{1,1}\left(\mathbf{R}^{n}\right) \hookrightarrow L^{1}\left(\mathbf{R}^{n}\right)$, we have by the Fourier inversion formula that

$$
f\left(x_{0}\right)=\frac{1}{(2 \pi)^{n}} \int_{\mathbf{R}^{n}} \lambda^{n} e^{i \lambda x_{0} \eta} \widehat{f}(\lambda \eta) d \eta .
$$

Thus, by putting $H(x, \xi)=\left[\widehat{h} * M_{-x} g_{0}\right](\xi)$, we see that

$$
\begin{aligned}
& \left(\left(H_{x_{0}}^{\lambda}\right)^{\wedge} * M_{-x} g_{0}\right)(\xi) \\
& =\frac{1}{(2 \pi)^{n}}\left[\left(f\left(x_{0}+\frac{\dot{\lambda}}{\lambda}\right)\right)^{\wedge} * \widehat{h} * M_{-x} g_{0}\right](\xi)-f\left(x_{0}\right)\left[\widehat{h} * M_{-x} g_{0}\right](\xi) \\
& =\frac{1}{(2 \pi)^{n}} \int_{\mathbf{R}^{n}} \lambda^{n} e^{i \lambda x_{0} \eta} \widehat{f}(\lambda \eta)(H(x, \xi-\eta)-H(x, \xi)) d \eta \\
& =\frac{1}{(2 \pi)^{n}} \int_{\mathbf{R}^{n}} e^{i x_{0} \eta} \widehat{f}(\eta)\left(H\left(x, \xi-\frac{\eta}{\lambda}\right)-H(x, \xi)\right) d \eta .
\end{aligned}
$$

Therefore, we have by the Fubini Theorem that

$$
\begin{aligned}
& \left\|H_{x_{0}}^{\lambda}\right\|_{M_{s}^{1,1}} \\
& \lesssim \int_{\mathbf{R}^{n}}|\widehat{f}(\eta)|\left(\iint_{\mathbf{R}^{2 n}}\langle\xi\rangle^{s}\left|H\left(x, \xi-\frac{\eta}{\lambda}\right)-H(x, \xi)\right| d x d \xi\right) d \eta .
\end{aligned}
$$

Moreover, by the submultiplicity of $\langle\cdot\rangle^{s}$ for $s \geq 0$, one has

$$
\langle\xi\rangle^{s} \lesssim\left\langle\xi-\frac{\eta}{\lambda}\right\rangle^{s}\left\langle\frac{\eta}{\lambda}\right\rangle^{s} \quad \text { and } \quad\left\langle\frac{\eta}{\lambda}\right\rangle \approx 1+\left|\frac{\eta}{\lambda}\right| \leq 1+|\eta| \approx\langle\eta\rangle
$$

for large $\lambda$, and thus

$$
|\widehat{f}(\eta)| \iint_{\mathbf{R}^{2 n}}\langle\xi\rangle^{s}\left|H\left(x, \xi-\frac{\eta}{\lambda}\right)-H(x, \xi)\right| d x d \xi \lesssim\langle\eta\rangle^{s}|\widehat{f}(\eta)|\|h\|_{M_{s}^{1,1}}
$$

Assume now that (9) is not valid, i.e., there exists $\varepsilon_{0}>0$ such that for some sequence $\left\{\lambda_{n}\right\}_{n=1}^{\infty}$ with $\lim _{n \rightarrow \infty} \lambda_{n}=\infty$, one has $\left\|H_{x_{0}}^{\lambda_{n}}\right\|_{M_{s}^{1,1}} \geq$ $\varepsilon_{0}$. But this is not possible since the Lebesgue dominated convergence theorem implies that $\left\|H_{x_{0}}^{\lambda_{n}}\right\|_{M_{s}^{1,1}} \rightarrow 0(n \rightarrow \infty)$. This implies (9).

Lemma 5.3. Given $1 \leq p<\infty, s \geq 0, f \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right), \tau \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ and $x_{0} \in \mathbf{R}^{n}$. For $\lambda>0$, we define

$$
G_{x_{0}}^{\lambda}(x)=\left(f\left(x_{0}+\frac{x}{\lambda}\right)-f\left(x_{0}\right)\right) \tau(x) .
$$

Then we have

$$
\lim _{\lambda \rightarrow \infty}\left\|G_{x_{0}}^{\lambda}\right\|_{M_{s}^{p, 1}}=0
$$

Proof. Suppose that $\lambda>0$ and supp $\tau \subset B_{\lambda}(0)$. Take $\psi \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ such that $\psi(x)=1$ on $B_{2}\left(x_{0}\right)$. Since $\psi\left(x_{0}\right)=1$ and $\psi\left(x_{0}+\frac{x}{\lambda}\right)=1$ on $\operatorname{supp} \tau$, we see that

$$
\left(f\left(x_{0}+\frac{x}{\lambda}\right)-f\left(x_{0}\right)\right) \tau(x)=\left((f \psi)\left(x_{0}+\frac{x}{\lambda}\right)-(f \psi)\left(x_{0}\right)\right) \tau(x)
$$

for all $x \in \mathbf{R}^{n}$. On the other hand, Lemma 2.5 implies that

$$
\|f \psi\|_{M_{s}^{1,1}} \lesssim\|f\|_{M_{s}^{\infty, 1}}\|\psi\|_{M_{s}^{1,1}} \lesssim\|f\|_{M_{s}^{p, 1}}\|\psi\|_{M_{s}^{1,1}}
$$

and thus $f \psi \in M_{s}^{1,1}\left(\mathbf{R}^{n}\right)$. Hence, it follows from Lemma 5.2 that

$$
\left\|G_{x_{0}}^{\lambda}\right\|_{M_{s}^{p, 1}} \lesssim\left\|G_{x_{0}}^{\lambda}\right\|_{M_{s}^{1,1}}=\left\|\left((f \psi)\left(x_{0}+\frac{\dot{\lambda}}{\lambda}\right)-(f \psi)\left(x_{0}\right)\right) \tau\right\|_{M_{s}^{1,1}} \rightarrow 0
$$

as $\lambda \rightarrow \infty$.
Lemma 5.4. Let $f, K$ and $F$ be as in Theorem 5.1, and $x_{0} \in K$. Then there exists $g_{x_{0}} \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ such that $g_{x_{0}}(x)=F(f(x))$ on some neighborhood of $x_{0}$.

Proof. Set $z_{0}=f\left(x_{0}\right)$. Since $F$ is analytic at $z_{0}$, there exists $0<$ $\varepsilon_{0}<1$ such that $F(z)$ has the power series expansion

$$
F(z)=F\left(z_{0}\right)+\sum_{j=1}^{\infty} c_{j}\left(z-z_{0}\right)^{j} \quad\left(\left|z-z_{0}\right|<\varepsilon_{0}\right)
$$

Let $\tau \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ be a function which is 1 near the origin. Then it follows from Lemma 5.3 that there exists $\lambda_{x_{0}}>0$ such that $\|\left(f\left(x_{0}+\right.\right.$ $\left.\left.\frac{\dot{\lambda}}{\lambda_{x_{0}}}\right)-f\left(x_{0}\right)\right) \tau \|_{M_{s}^{p, 1}}<\varepsilon_{0} / c$, where the constant $c$ is as in Lemma 2.2 (iv). Thus we see that

$$
b_{x_{0}}(x)=F\left(f\left(x_{0}\right)\right) \tau(x)+\sum_{j=1}^{\infty} c_{j}\left(\left(f\left(x_{0}+\frac{x}{\lambda_{x_{0}}}\right)-f\left(x_{0}\right)\right) \tau(x)\right)^{j}
$$

converges in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. Hence

$$
\begin{aligned}
g_{x_{0}}(x) & =b_{x_{0}}\left(\lambda_{x_{0}}\left(x-x_{0}\right)\right) \\
& =F\left(f\left(x_{0}\right)\right) \tau_{x_{0}}(x)+\sum_{j=1}^{\infty} c_{j}\left(\left(f(x)-f\left(x_{0}\right)\right) \tau_{x_{0}}(x)\right)^{j}
\end{aligned}
$$

is in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, where we denote $\tau_{x_{0}}(x)=\tau\left(\lambda_{x_{0}}\left(x-x_{0}\right)\right)$. Moreover, since $g_{x_{0}}(x)=F(f(x))$ in some neighborhood of $x_{0}$, we obtain the desired result.

Now we prove Theorem 5.1 by extending the local result above to the compact set $K$.

The proof of Theorem 5.1. We first note that by Lemma 5.4, we have for each $x_{0} \in K$, there exist $\tau_{x_{0}} \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ and a neighborhood $U_{x_{0}}$ of $x_{0}$ such that $g_{x_{0}}$ defined by

$$
g_{x_{0}}(x)=F\left(f\left(x_{0}\right)\right) \tau_{x_{0}}(x)+\sum_{j=1}^{\infty} c_{j}\left(\left(f(x)-f\left(x_{0}\right)\right) \tau_{x_{0}}(x)\right)^{j}
$$

satisfies $g_{x_{0}}(x)=F(f(x))$ on $U_{x_{0}}$. Since $K \subset \bigcup_{x_{0} \in K} U_{x_{0}}$ and $K$ is compact, there exist $\left\{x_{j}\right\}_{j=1}^{N} \subset K$ such that the corresponding neighborhoods $\left\{U_{x_{j}}\right\}_{j=1}^{N}$ cover $K$. Now we set $h_{1}(x)=\tau_{x_{1}}(x)$ and

$$
h_{j}(x)=\tau_{x_{j}}(x)\left(1-\tau_{x_{1}}(x)\right) \cdots\left(1-\tau_{x_{j-1}}(x)\right) \quad(j=2,3, \cdots, N) .
$$

Since $\tau_{x_{j}}(x)=1$ and $g_{x_{j}}(x)=F(f(x))$ on $U_{x_{j}}(j=1, \cdots, N)$, it is easily see that $\sum_{j=1}^{N} h_{j}(x)=1$ on $K$. Therefore $g \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ defined by $g(x)=\sum_{j=1}^{N} h_{j}(x) g_{x_{j}}(x)$ satisfies

$$
g(x)=\sum_{j=1}^{N} h_{j}(x) F(f(x))=F(f(x)) \sum_{j=1}^{N} h_{j}(x)=F(f(x)) .
$$

for all $x \in K$, which yields the desired result.
Under a mild extra condition on $f$ respectively $F$, one can extend the local result to the following global result.

Theorem 5.5. Let $1 \leq p<\infty, s \geq 0, f \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ and $F$ be analytic on an open neighborhood of $f\left(\mathbf{R}^{n}\right) \cup\{0\}$ with $F(0)=0$. Then there exists $g \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ such that $g(x)=F(f(x))$.

Proof. Since $F$ is analytic on a neighborhood of 0 with $F(0)=0$, there exists $\varepsilon_{0}>0$ such that $F(z)$ has the power series representation

$$
F(z)=\sum_{j=1}^{\infty} c_{j} z^{j} \quad\left(|z|<\varepsilon_{0}\right) .
$$

It follows from Theorem 3.1 that for any $\varepsilon$ with $0<\varepsilon<\varepsilon_{0}$, there exists $\phi \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ such that

$$
\|f-\phi f\|_{L^{\infty}} \lesssim\|f-\phi f\|_{M_{s}^{p, 1}}<\varepsilon / c,
$$

where the constant $c$ is as in Lemma 2.2 (iv). Now we set

$$
g_{0}(x)=\sum_{j=1}^{\infty} c_{j}(f(x)-\phi(x) f(x))^{j}
$$

Then we have $g_{0} \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ and $g_{0}(x)=F(f(x)-\phi(x) f(x))=$ $F(f(x))(x \notin \operatorname{supp} \phi)$. On the other hand, let $\tau_{0} \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ be such that $\tau_{0}(x)=1$ on supp $\phi$. Then it follow from Theorem 5.1 that there
exists exists $g_{1} \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ such that $g_{1}(x)=F(f(x))$ on $\operatorname{supp} \tau_{0}$. Now we set

$$
g(x)=\left(1-\tau_{0}(x)\right) g_{0}(x)+\tau_{0}(x) g_{1}(x) .
$$

We note that $g \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. If $x \in \operatorname{supp} \phi$, then $\tau_{0}(x)=1$ and $g_{1}(x)=$ $F(f(x))$, and thus $g(x)=F(f(x))$. Moreover, if $x \in \operatorname{supp} \tau_{0} \backslash \operatorname{supp} \phi$, then $g_{0}(x)=F(f(x)-\phi(x) f(x))=F(f(x))$ and $g_{1}(x)=F(f(x))$, and thus $g(x)=F(f(x))$. Finally, if $x \notin \operatorname{supp} \tau_{0}$, then $\tau_{0}(x)=0$ and $g_{0}(x)=F(f(x))$, and thus $g(x)=F(f(x))$. Hence we obtain the desired result.

As an application of Theorem 5.1, we obtain the following version of Wiener's general Tauberian theorem for $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ (cf. [31, Theorem 1.4.1], [20, Ch VIII. 6.4]).

Theorem 5.6. Let $1 \leq p<\infty, s \geq 0, f \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ and I be a closed ideal in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. If I is generated by one function $f$ in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, then we have: $I=M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ if and only if $f(x) \neq 0\left(x \in \mathbf{R}^{n}\right)$.

Proof. Suppose that $I=M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. Since $I$ is the closed ideal generated by $f \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, we see that $I$ is equal to the closure in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ of the set

$$
\left\{\sum_{j=1}^{N} \lambda_{j} \phi_{j} f \mid \lambda_{j} \in \mathbf{C}, \phi_{j} \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right), N \in \mathbf{N}\right\} .
$$

If $f\left(x_{0}\right)=0$ for some $x_{0} \in \mathbf{R}^{n}$, then we have $g\left(x_{0}\right)=0$ for all $g \in I$. Since $\mathcal{S}\left(\mathbf{R}^{n}\right) \subset M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, this contradicts $I=M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$.

Conversely, suppose that $f(x) \neq 0$ for all $x \in \mathbf{R}^{n}$. Let $K$ be a compact subset of $\mathbf{R}^{n}$ and $\phi \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ be such that $\operatorname{supp} \phi \subset K$. Since $F(z)=\frac{1}{z}$ is analytic on $\mathbf{C} \backslash\{0\}$ and $f(x) \neq 0$ for all $x \in K$, it follows from Theorem 5.11 that there exists $g \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ such that $f g=1$ on $K$. Since $f \in I$ and $I$ is an ideal in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, we have $\phi=\phi g \cdot f \in I$. Moreover, since $C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ is dense in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ (cf. Lemma 2.2 and Proposition 3.1), we obtain $I=M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$.

Remark 5.7. By Lemma 4.4, the ideal $I$ in Theorem 5.6 is a closed modulation invariant subspace of $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. Thus $I$ is equal to the closure in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ of the set

$$
A=\left\{\sum_{j=1}^{N} \lambda_{j} e^{i \eta_{j} x} f(x) \mid \lambda_{j} \in \mathbf{C}, \eta_{j} \in \mathbf{R}^{n}, N \in \mathbf{N}\right\}
$$

As a corollary of Theorem 5.6, we also obtain a variant of Wiener's approximation theorem for the Wiener amalgam space $W\left(\mathcal{F} L^{p}, \ell_{s}^{1}\right)\left(\mathbf{R}^{n}\right)$ (cf. [31, Theorem 1.4.8]).

Corollary 5.8. Let $1 \leq p<\infty, s \geq 0$ and $W\left(\mathcal{F} L^{p}, \ell_{s}^{1}\right)\left(\mathbf{R}^{n}\right)$ be the Wiener amalgam space consisting of all $\widehat{f} \in \mathcal{S}^{\prime}\left(\mathbf{R}^{n}\right)$ such that $f \in$ $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ with the norm $\|\widehat{f}\|_{W\left(\mathcal{F} L^{p}, \ell_{s}^{1}\right)}=\|f\|_{M_{s}^{p, 1}}$. Then for any $\widehat{f} \in$ $W\left(\mathcal{F} L^{p}, \ell_{s}^{1}\right)\left(\mathbf{R}^{n}\right)$, we have that $f(x) \neq 0$ for all $x \in \mathbf{R}^{n}$ if and only if the set

$$
\mathcal{F}(A)=\left\{\sum_{j=1}^{N} \lambda_{j} \widehat{f}\left(\xi-\eta_{j}\right) \mid \lambda_{j} \in \mathbf{C}, \eta_{j} \in \mathbf{R}^{n}, N \in \mathbf{N}\right\}
$$

is dense in $W\left(\mathcal{F} L^{p}, \ell_{s}^{1}\right)\left(\mathbf{R}^{n}\right)$.
Proof. Let $\widehat{f} \in W\left(\mathcal{F} L^{p}, \ell_{s}^{1}\right)\left(\mathbf{R}^{n}\right)$. We first assume that $f(x) \neq 0$ for all $x \in \mathbf{R}^{n}$. Then Remark 5.7 implies that for any $g \in W\left(\mathcal{F} L^{p}, \ell_{s}^{1}\right)\left(\mathbf{R}^{n}\right)$ and $\varepsilon>0$, there exist $\left\{\lambda_{j}\right\}_{j=1}^{N} \subset \mathbf{C}$ and $\left\{\eta_{j}\right\}_{j=1}^{N} \subset \mathbf{R}^{n}$ such that

$$
\left\|\widehat{g}-\sum_{j=1}^{N} \lambda_{j} \widehat{f}\left(\xi-\eta_{j}\right)\right\|_{W\left(\mathcal{F} L^{p}, \ell_{s}^{1}\right)}=\left\|g-\sum_{j=1}^{N} \lambda_{j} e^{i n_{j} x} f(x)\right\|_{M_{s}^{p, 1}}<\varepsilon
$$

holds. Therefore, $\mathcal{F}(A)$ is dense in $W\left(\mathcal{F} L^{p}, \ell_{s}^{1}\right)\left(\mathbf{R}^{n}\right)$. Conversely, we assume that $\mathcal{F}(A)$ is dense in $W\left(\mathcal{F} L^{p}, \ell_{s}^{1}\right)\left(\mathbf{R}^{n}\right)$. Then the set $A$ in Remark 5.7 is dense in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. Hence Theorem 5.6 implies that $f(x) \neq 0$ for all $x \in \mathbf{R}^{n}$.
Remark 5.9. The same principles apply for the case of e.g. finitely many functions $f_{1}, \cdots, f_{\ell}$ without common zero.

## 6. Set of spectral synthesis for $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$

In this section, we consider the set of spectral synthesis for $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. Throughout this section, $X$ stands for $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)(1 \leq p<\infty, s \geq 0)$ or $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)(s \geq 0)$.

Definition 6.1. Let $E$ be a closed subset of $\mathbf{R}^{n}$ and $I(E)$ be the set defined in Lemma 4.3. Define $J(E)$ by the closed ideal in $X$ generated by

$$
J_{0}(E)=\{f \in X \mid f(x)=0 \text { in a neighborhood of } E\} .
$$

Then $E$ is called a set of spectral synthesis for $X$ if $I(E)=J(E)$.
Remark 6.2 . We can easily see that $E$ is a set of spectral synthesis for $X$ if and only if $x+E$ is a set of spectral synthesis for $X$ for some/any $x \in \mathbf{R}^{n}$.

In the following, we shall prove the following.
Theorem 6.3. Let $1 \leq p \leq 2, s \geq 0$ and $K$ be a compact subset of $\mathbf{R}^{n}$. Then $K$ is a set of spectral synthesis for $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ if and only if $K$ is a set of spectral synthesis for $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$.
6.1. Technical lemmas. To prove Theorem 6.3, we use the "ideal theory for Segal algebras" developed in Reiter [30, Ch.6, §2] (see also [5], [31]). In the following, we denote by $\left(\mathcal{F} L_{s}^{1}\right)_{c}$ the space defined in Lemma 2.10.

Lemma 6.4. Let $s \geq 0$ and $I$ be a closed ideal in $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$. Then $I$ is the closure of $I \cap\left(\mathcal{F} L_{s}^{1}\right)_{c}$ in $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$.
Proof. Since $I \cap\left(\mathcal{F} L_{s}^{1}\right)_{c} \subset I$ and $I$ is closed in $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$, the closure of $I \cap\left(\mathcal{F} L_{s}^{1}\right)_{c}$ in $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$ is contained in $I$. We next show that $I$ is contained in the closure of $I \cap\left(\mathcal{F} L_{s}^{1}\right)_{c}$ in $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$. Let $f \in I$. Then we have by Lemma 2.8 that for any $\varepsilon>0$, there exists $\phi \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ such that $\|f-\phi f\|_{\mathcal{F} L_{s}^{1}}<\varepsilon$ holds. Since $I$ is an ideal in $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$, we have $\phi f \in I \cap\left(\mathcal{F} L_{s}^{1}\right)_{c}$. Hence we obtain the desired result.
Lemma 6.5. Let $1 \leq p \leq 2$ and $s \geq 0$. Suppose that $I$ and $I^{\prime}$ are closed ideals in $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$. Then we have the following:
(i) $I \cap M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ is a closed ideal in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$.
(ii) If $I \cap M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)=I^{\prime} \cap M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, then we have $I=I^{\prime}$.

Proof. (i) We first prove that $I \cap M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ is an ideal in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. Let $f \in I \cap M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ and $g \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. Since $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ is a multiplication algebra, we see $f g \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. Moreover, since $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right) \hookrightarrow$ $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$ and $I$ is an ideal in $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$, we have $f g \in I$. Hence we $f g \in I \cap M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ for any $f \in I \cap M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ and $g \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, which implies the desired result. We next prove $I \cap M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ is closed in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. Let $f$ be in the closure of $I \cap M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. Then, there exists $\left\{f_{n}\right\}_{n=1}^{\infty} \subset I \cap M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ such that $\left\|f_{n}-f\right\|_{M_{s}^{p, 1}} \rightarrow 0(n \rightarrow$ $\infty$ ). We note that $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right) \hookrightarrow \mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$, and thus $\left\|f_{n}^{M_{s}}-f\right\|_{\mathcal{F} L_{s}^{1}} \rightarrow 0$ $(n \rightarrow \infty)$. Since $I$ is closed in $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$ and $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ is complete, we obtain $f \in I \cap M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, which implies the desired result.
(ii) Since $I \cap M_{s}^{p, 1} \cap\left(\mathcal{F} L_{s}^{1}\right)_{c}=I^{\prime} \cap M_{s}^{p, 1} \cap\left(\mathcal{F} L_{s}^{1}\right)_{c}$ and $\left(\mathcal{F} L_{s}^{1}\right)_{c} \hookrightarrow$ $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, we have $I \cap\left(\mathcal{F} L_{s}^{1}\right)_{c}=I^{\prime} \cap\left(\mathcal{F} L_{s}^{1}\right)_{c}$. Thus it follows from Lemma 6.4 that $I=I^{\prime}$, which implies the desired result.

Proposition 6.6. Let $1 \leq p \leq 2$ and $s \geq 0$. Then for any closed ideal $I_{M}$ in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, the ideal $I_{F}$ in $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$ defined by the closure of $I_{M}$ in $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$ satisfies $I_{M}=I_{F} \cap M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$.
Proof. Let $I_{M}$ be a closed ideal in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ and define $I_{F}^{\prime}$ by the closure of $I_{M} \cap\left(\mathcal{F} L_{s}^{1}\right)_{c}$ in $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$. Then $I_{F}^{\prime}$ is a closed ideal in $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$. To see $I_{F}^{\prime}$ is an ideal in $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$, let $f \in I_{F}^{\prime}$ and $g \in \mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$. Then there exists $\left\{f_{n}\right\}_{n=1}^{\infty} \subset I_{M} \cap\left(\mathcal{F} L_{s}^{1}\right)_{c}$ such that $\left\|f-f_{n}\right\|_{\mathcal{F} L_{s}^{1}} \rightarrow 0$ $(n \rightarrow \infty)$. Since $f_{n} \in\left(\mathcal{F} L_{s}^{1}\right)_{c}$, there exists $\psi_{n} \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ such that
$\psi_{n}(x)=1$ on supp $f_{n}$. Then we have $\psi_{n} g \in\left(\mathcal{F} L_{s}^{1}\right)_{c} \hookrightarrow M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. Therefore, $\psi_{n} g \cdot f_{n} \in I_{M}$, and thus $f_{n} g=f_{n} \cdot \psi_{n} g \in I_{M} \cap\left(\mathcal{F} L_{s}^{1}\right)_{c}$. Moreover, since

$$
\left\|f g-f_{n} g\right\|_{\mathcal{F} L_{s}^{1}} \lesssim\left\|f-f_{n}\right\|_{\mathcal{F} L_{s}^{1}}\|g\|_{\mathcal{F} L_{s}^{1}} \rightarrow 0 \quad(n \rightarrow \infty),
$$

we have $f g \in I_{F}^{\prime}$. Hence, $I_{F}^{\prime}$ is an ideal in $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$.
Next, we prove that $I_{F}$ is equal to $I_{F}^{\prime}$. Let $f \in I_{F}$. Then for any $\varepsilon>0$, there exists $g \in I_{M}$ such that $\|f-g\|_{\mathcal{F} L_{s}^{1}}<\varepsilon$. On the other hand, Theorem 3.1 implies that there exists $\phi \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ such that $\|g-\phi g\|_{M_{s}^{p, 1}}<\varepsilon$. Hence we have $\phi g \in I_{M} \subset M_{s}^{p, 1}\left(\mathbf{R}^{n}\right) \hookrightarrow \mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$. Hence we obtain $\phi g \in I_{M} \cap\left(\mathcal{F} L_{s}^{1}\right)_{c}$ and

$$
\begin{aligned}
\|f-\phi g\|_{\mathcal{F} L_{s}^{1}} & \leq\|f-g\|_{\mathcal{F} L_{s}^{1}}+\|\phi g-g\|_{\mathcal{F} L_{s}^{1}} \\
& \lesssim\|f-g\|_{\mathcal{F} L_{s}^{1}}+\|\phi g-g\|_{M_{s}^{p, 1}} \lesssim \varepsilon,
\end{aligned}
$$

which yields $I_{F} \subset I_{F}^{\prime}$. The reverse inclusion is clear.
Finally, we prove $I_{M}=I_{F} \cap M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. Since $I_{M} \subset I_{F}$ and $I_{M} \subset$ $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, we see that $I_{M}=I_{M} \cap M_{s}^{p, 1}\left(\mathbf{R}^{n}\right) \subset I_{F} \cap M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. On the other hand, let $f \in I_{F} \cap M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ and $\varepsilon>0$. By Theorem 3.1, there exists $\phi \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ such that $\|f-\phi f\|_{M_{s}^{p, 1}}<\varepsilon$. Now we take $\varphi \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ with $\varphi(x)=1$ on $\operatorname{supp} \phi$. Since $f \in I_{F}=I_{F}^{\prime}$, there exists $h \in I_{M} \cap\left(\mathcal{F} L_{s}^{1}\right)_{c}$ such that $\|f-h\|_{\mathcal{F} L_{s}^{1}}<\frac{\varepsilon}{\|\varphi\|_{M_{s}^{p, 1}}^{p, 1 \phi \|_{\mathcal{F} L_{s}^{1}}}}$. Then we have $\phi h \in I_{M}$. Since $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right) \hookrightarrow M_{s}^{\infty, 1}\left(\mathbf{R}^{n}\right)$ (see the proof of Lemma 2.10), we obtain

$$
\begin{aligned}
\|f-\phi h\|_{M_{s}^{p, 1}} & \lesssim\|f-\phi f\|_{M_{s}^{p, 1}}+\|\varphi \phi(f-h)\|_{M_{s}^{p, 1}} \\
& \lesssim\|f-\phi f\|_{M_{s}^{p, 1}}+\|\varphi\|_{M_{s}^{p, 1}}\|\phi(f-h)\|_{M_{s}^{\infty, 1}} \\
& \lesssim\|f-\phi f\|_{M_{s}^{p, 1}}+\|\varphi\|_{M_{s}^{p, 1}}\|\phi(f-h)\|_{\mathcal{F} L_{s}^{1}} \\
& \lesssim\|f-\phi f\|_{M_{s}^{p, 1}}+\|\varphi\|_{M_{s}^{p, 1}}\|\phi\|_{\mathcal{F} L_{s}^{1}}\|f-h\|_{\mathcal{F} L_{s}^{1}} .
\end{aligned}
$$

Therefore $f$ is in the closure of $I_{M}$ in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. Since $I_{M}$ is closed in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, we get the desired result.

Remark 6.7. Let $I_{M}$ and $I_{M}^{\prime}$ be closed ideals in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, and $I_{F}$ be the closure of $I_{M}$ in $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$. If the closure of $I_{M}^{\prime}$ in $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$ is equal to $I_{F}$, then Proposition 6.6 implies that $I_{M}=I_{M}^{\prime}$.

Combining Lemma 6.5 and Proposition 6.6, we obtain the following result.

Theorem 6.8 (The ideal theory for Segal algebras). Let $1 \leq p \leq 2$, $s \geq 0, \mathcal{I}_{F}$ be the set of all closed ideals in $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$, and $\mathcal{I}_{M}$ be the
set of all closed ideals in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. Define the map $\iota: \mathcal{I}_{F} \rightarrow \mathcal{I}_{M}$ by $\iota\left(I_{F}\right)=I_{F} \cap M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. Then $\iota$ is bijective. More precisely, we have

$$
\iota^{-1}\left(I_{M}\right)={\overline{I_{M}}}_{\|\cdot\|_{\mathcal{F} L_{s}^{1}}} \quad\left(I_{M} \in \mathcal{I}_{M}\right)
$$

and

$$
\iota\left(\overline{I_{M}}{ }^{\|\cdot\|_{\mathcal{F} L_{s}^{1}}}\right)=\overline{I_{M}}{ }^{\|\cdot\|_{\mathcal{F} L_{s}^{1}}} \cap M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)=I_{M},
$$

where $\overline{I_{M}}\|\cdot\|_{\mathcal{F L} L_{s}^{1}}$ denotes the closure of $I_{M}$ in $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$.
6.2. The proof of Theorem 6.3. For a closed subset $K$ of $\mathbf{R}^{n}$, we set $I_{F}(K)=\left\{f \in \mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)|f|_{K}=0\right\}$ and $I_{M}(K)=\{f \in$ $\left.M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)|f|_{K}=0\right\}$. Moreover, we define $J_{F}(K)$ by the closure of $\{f \in$ $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right) \mid f(x)=0$ in a neighborhood of $\left.K\right\}$ in $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$, and $J_{M}(K)$ by the closure of $\left\{f \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right) \mid f(x)=0\right.$ in a neighborhood of $\left.K\right\}$ in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. We note that $J_{F}(K)$ is the smallest closed ideal $I$ in $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$ such that $\bigcap_{f \in I} f^{-1}(\{0\})=K$ (cf. [31, Proposition 2.4.5]). Similarly, $J_{M}(K)$ is the smallest closed ideal $I$ in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ such that $\bigcap_{f \in I} f^{-1}(\{0\})=K$ (cf. Theorems 5.1 and 5.5). Thus Proposition 6.6 implies that $I_{F}(K)=J_{M}(K)$ if and only if $I_{F}(K)=J_{F}(K)$. Therefore, $K$ is a set of spectral synthesis for $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ if and only if $K$ is a set of spectral synthesis for $\mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$.
6.3. Examples. As an application of Theorem 6.3, we show some concrete examples of sets of spectral synthesis for $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$.

Example 6.9 (cf. [31, Theorem 2.7.6]). Let $1 \leq p \leq 2$. Then a circle in $\mathbf{R}^{2}$ is a set of spectral synthesis for $M_{s}^{p, 1}\left(\mathbf{R}^{2}\right)$ if $0 \leq s<\frac{1}{2}$, but not if $s \geq \frac{1}{2}$.
Example 6.10 (cf. [31, Theorem 2.7.7]). Let $1 \leq p \leq 2$ and $s \geq$ 0 . Then the sphere $S^{n-1} \subset \mathbf{R}^{n}$ is not a set of spectral synthesis for $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ if $n \geq 3$.

Example 6.11 (cf. [31, Theorem 2.7.9]). Let $1 \leq p \leq 2$. Single points of $\mathbf{R}^{n}$ are sets of spectral synthesis for $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, if $0 \leq s<1$.
Example 6.12 (cf. [31, Theorem 2.7.10]). Let $1 \leq p \leq 2$ and $s \geq 0$. Then a closed ball in $\mathbf{R}^{n}$ is a set of spectral synthesis for $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ and so is the complement of an open ball in $\mathbf{R}^{n}$.

## 7. Spectral synthesis Revisited

As mentioned in Section 6.3, if $1 \leq p \leq 2$ and $0 \leq s<1$, then single points of $\mathbf{R}^{n}$ are sets of spectral synthesis for $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$. In this section we will prove it directly without using Theorem 6.3, and this is also true for $p>2$.

Theorem 7.1. Let $1 \leq p<\infty, 0 \leq s<1$ and $x_{0} \in \mathbf{R}^{n}$. Then $\left\{x_{0}\right\}$ is a set of spectral synthesis in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$.

### 7.1. Technical Lemma.

Lemma 7.2. For any $t_{0} \in \mathbf{R}^{n}$ and $R>0$, there exist $\psi^{(1)}, \psi^{(2)} \in$ $C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ such that $\psi=\psi^{(1)} * \psi^{(2)}$ satisfies $\psi(x)=1$ on $B_{R}\left(t_{0}\right)$ and $\operatorname{supp} \psi \subset B_{5 R}\left(t_{0}\right)$.

Proof. Let $g \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ be such that $g(x) \geq 0\left(x \in \mathbf{R}^{n}\right), g(x)=1$ on $B_{R}(0)$ and supp $g \subset B_{2 R}(0)$. Define $\psi^{(1)}, \psi^{(2)} \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ by

$$
\psi^{(1)}(x)=g\left(\frac{x}{2}\right) \quad \text { and } \quad \psi^{(2)}(x)=\frac{2^{n}}{\|g\|_{L^{1}}} g\left(2\left(x-t_{0}\right)\right),
$$

respectively, and set $\psi=\psi^{(1)} * \psi^{(2)}$. Then $\psi$ satisfies the desired conditions. Indeed, we note that
$\psi(x)=\int_{\mathbf{R}^{n}} \psi^{(1)}(x-y) \psi^{(2)}(y) d y=\frac{2^{n}}{\|g\|_{L^{1}}} \int_{\mathbf{R}^{n}} g\left(\frac{x-y}{2}\right) g\left(2\left(y-t_{0}\right)\right) d y$.
Moreover, if $x \in B_{R}\left(t_{0}\right)$ and $\left|2\left(y-t_{0}\right)\right| \leq 2 R$, then we have $\frac{|x-y|}{2} \leq$ $\frac{\left|x-t_{0}\right|}{2}+\frac{\left|t_{0}-y\right|}{2} \leq R$, and thus $g\left(\frac{x-y}{2}\right)=1$. Therefore, we obtain

$$
\psi(x)=\left(\psi^{(1)} * \psi^{(2)}\right)(x)=\frac{2^{n}}{\|g\|_{1}} \int_{\mathbf{R}^{n}} g\left(2\left(y-t_{0}\right)\right) d y=1
$$

on $B_{R}\left(t_{0}\right)$. Also we have $\operatorname{supp} \psi^{(1)} \subset\left\{x \in \mathbf{R}^{n}| | x \mid \leq 4 R\right\}$ and $\operatorname{supp} \psi^{(2)} \subset\left\{x \in \mathbf{R}^{n}| | x-t_{0} \mid \leq R\right\}$, and thus we see supp $\psi \subset$ $\operatorname{supp} \psi^{(1)}+\operatorname{supp} \psi^{(2)} \subset\left\{x \in \mathbf{R}^{n}| | x-t_{0} \mid \leq 5 R\right\}$.

Lemma 7.3. Let $\psi^{(1)}, \psi^{(2)} \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ be such that $\operatorname{supp} \psi^{(j)} \subset B_{R}(0)$ for some $R>0(j=1,2)$. Define $\psi=\psi^{(1)} * \psi^{(2)}$. Then we have for $0 \leq s<1$ and $\vartheta \in \mathbf{R}^{n}$

$$
\int_{\mathbf{R}^{n}}\langle\xi\rangle^{s}|\widehat{\psi}(\xi-\vartheta)-\widehat{\psi}(\xi)| d \xi \leq C_{\psi}|\vartheta|^{s}\left(\max _{|t| \leq R}\left|e^{i \vartheta t}-1\right|\right)^{1-s}
$$

Proof. We first note that since $\widehat{\psi}=\widehat{\psi^{(1)}} \cdot \widehat{\psi^{(2)}}$, we have

$$
\begin{aligned}
& \widehat{\psi}(\xi-\vartheta)-\widehat{\psi}(\xi) \\
& =\left(\widehat{\psi^{(1)}}(\xi-\vartheta)-\widehat{\psi^{(1)}}(\xi)\right) \widehat{\psi^{(2)}}(\xi-\vartheta)+\widehat{\psi^{(1)}}(\xi)\left(\widehat{\psi^{(2)}}(\xi-\vartheta)-\widehat{\psi^{(2)}}(\xi)\right) .
\end{aligned}
$$

Then it follows from the Cauchy-Schwarz inequality and the Plancherel theorem that

$$
\begin{aligned}
& \int_{\mathbf{R}^{n}}\langle\xi\rangle^{s}|\widehat{\psi}(\xi-\vartheta)-\widehat{\psi}(\xi)| d \xi \\
& \leq\left(\int_{\mathbf{R}^{n}}\left|\widehat{\psi^{(1)}}(\xi-\vartheta)-\widehat{\psi^{(1)}}(\xi)\right|^{2} d \xi\right)^{\frac{1}{2}}\left(\int_{\mathbf{R}^{n}}\langle\xi\rangle^{2 s}\left|\widehat{\psi^{(2)}}(\xi-\vartheta)\right|^{2} d \xi\right)^{\frac{1}{2}} \\
& \quad+\left(\int_{\mathbf{R}^{n}}\left|\widehat{\psi^{(2)}}(\xi-\vartheta)-\widehat{\psi^{(2)}}(\xi)\right|^{2} d \xi\right)^{\frac{1}{2}}\left(\int_{\mathbf{R}^{n}}\langle\xi\rangle^{2 s}\left|\widehat{\psi^{(1)}}(\xi-\vartheta)\right|^{2} d \xi\right)^{\frac{1}{2}} \\
& =\left\|\mathcal{F}_{x \rightarrow \xi}\left[\left(e^{i \vartheta x}-1\right) \psi^{(1)}(x)\right](\xi)\right\|_{L^{2}\left(\mathbf{R}_{\xi}^{n}\right)}\langle\vartheta\rangle^{s}\left\|\langle\xi\rangle^{s} \widehat{\psi^{(2)}}(\xi)\right\|_{L^{2}\left(\mathbf{R}_{\xi}^{n}\right)} \\
& \quad+\left\|\mathcal{F}_{x \rightarrow \xi}\left[\left(e^{i \vartheta x}-1\right) \psi^{(2)}(x)\right](\xi)\right\|_{L^{2}\left(\mathbf{R}_{\xi}^{n}\right)}\langle\vartheta\rangle^{s}\left\|\langle\xi\rangle^{s} \widehat{\psi^{(1)}}(\xi)\right\|_{L^{2}\left(\mathbf{R}_{\xi}^{n}\right)} .
\end{aligned}
$$

We note that $\left|e^{i \vartheta x}-1\right| \leq \min \{2,|\vartheta x|\}$, and for $j=1,2$, it follows from the Plancherel Theorem that

$$
\left\|\mathcal{F}_{x \rightarrow \xi}\left[\left(e^{i \vartheta x}-1\right) \psi^{(j)}(x)\right](\xi)\right\|_{L^{2}\left(\mathbf{R}_{\xi}^{n}\right)}=(2 \pi)^{\frac{n}{2}}\left\|\left(e^{i \vartheta x}-1\right) \psi^{(j)}(x)\right\|_{L^{2}\left(\mathbf{R}_{x}^{n}\right)}
$$

Moreover, since supp $\psi^{(j)} \subset B_{R}(0)(j=1,2)$, we obtain

$$
\begin{aligned}
& \left\|\mathcal{F}_{x \rightarrow \xi}\left[\left(e^{i \vartheta x}-1\right) \psi^{(j)}(x)\right](\xi)\right\|_{L^{2}\left(\mathbf{R}_{\xi}^{n}\right)}\left(1+|\vartheta|^{s}\right) \\
& \lesssim\left(\max _{|x| \leq R}\left|e^{i \vartheta x}-1\right|\right)^{1-s}\left(\int_{\mathbf{R}^{n}}\left(\left|e^{i \vartheta x}-1\right|^{s}\left|\psi^{(j)}(x)\right|\right)^{2} d x\right)^{\frac{1}{2}}\left(1+|\vartheta|^{s}\right) \\
& \leq|\vartheta|^{s}\left(\max _{|x| \leq R}\left|e^{i \vartheta x}-1\right|\right)^{1-s}\left(\int_{\mathbf{R}^{n}}\left(|x|^{s}\left|\psi^{(j)}(x)\right|\right)^{2} d x\right)^{\frac{1}{2}} \\
& \quad+2^{s}|\vartheta|^{s}\left(\max _{|x| \leq R}\left|e^{i \vartheta x}-1\right|\right)^{1-s}\left(\int_{\mathbf{R}^{n}}\left|\psi^{(j)}(x)\right|^{2} d x\right)^{\frac{1}{2}}
\end{aligned}
$$

which yields the desired inequality.

Now we prepare a lemma, which corresponds to a weighted version of Bhimani-Ratnakumar [3, Proposition 3.14].

Lemma 7.4. Let $0 \leq s<1, f \in M_{s}^{1,1}\left(\mathbf{R}^{n}\right), x_{0} \in \mathbf{R}^{n}$ and $\varepsilon>0$. Then there exists $\phi \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ such that
(i) $\left\|\left(f-f\left(x_{0}\right)\right) \phi\right\|_{M_{s}^{1,1}}<\varepsilon$
(ii) $\phi(x)=1$ in some neighborhood of $x_{0}$.

Proof. Take $\psi=\psi^{(1)} * \psi^{(2)} \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ as in Lemma 7.2 with $t_{0}=0$ and $R=1$, i.e., $\psi(x)=1$ on $B_{1}(0)$ and $\operatorname{supp} \psi \subset B_{5}(0)$. Define $\psi_{\lambda}(x)=\psi(\lambda x)$ and $h^{\lambda}(x)=\left(f(x)-f\left(x_{0}\right)\right) \psi_{\lambda}\left(x-x_{0}\right)$ for $\lambda>0$. We note that if $\lambda>5$ and $x \in \operatorname{supp} h^{\lambda}$, then $\psi\left(x-x_{0}\right)=1$. Thus $h^{\lambda}(x)=h^{\lambda}(x) \psi\left(x-x_{0}\right)$.

Without loss of generality, we may assume $x_{0}=0$ (see Remark 6.2). Let $g_{0}(t)=e^{-\frac{|t|^{2}}{2}}\left(t \in \mathbf{R}^{n}\right)$ and $\lambda>5$. By (1) in Section 2.1, we have

$$
\begin{aligned}
\left\|h^{\lambda}\right\|_{M_{s}^{1,1}} & =\| \|\langle\xi\rangle^{s} V_{g_{0}} h^{\lambda}(x, \xi)\left\|_{L^{1}\left(\mathbf{R}_{x}^{n}\right)}\right\|_{L^{1}\left(\mathbf{R}_{\xi}^{n}\right)} \\
& =(2 \pi)^{-n}\| \|\langle\xi\rangle^{s} V_{\widehat{g_{0}}} \widehat{h^{\lambda}}(\xi,-x)\left\|_{L^{1}\left(\mathbf{R}_{x}^{n}\right)}\right\|_{L^{1}\left(\mathbf{R}_{\xi}^{n}\right)} .
\end{aligned}
$$

Since $\widehat{g_{0}}=(2 \pi)^{\frac{n}{2}} g_{0}, g_{0}^{*}=g_{0}$ and $h^{\lambda}(x)=h^{\lambda}(x) \psi(x)$, we obtain by (1) in Section 2.1

$$
\left.V_{\widehat{g_{0}}} \widehat{h^{\lambda}}(\xi,-x)=(2 \pi)^{-\frac{n}{2}} V_{g_{0}} \widehat{\left(h^{\lambda}\right.} * \widehat{\psi}\right)(\xi,-x)=(2 \pi)^{-\frac{n}{2}} e^{i x \xi}\left(\widehat{h^{\lambda}} * \widehat{\psi} * M_{-x} g_{0}\right)(\xi) .
$$

Thus by the Fubini Theorem and the Minkowski inequality for integral that

$$
\begin{aligned}
\left\|h^{\lambda}\right\|_{M_{s}^{1,1}} & =(2 \pi)^{-n}\| \|\langle\xi\rangle^{s} V_{\widehat{g_{0}}} \widehat{\widehat{\lambda}}(\xi,-x)\left\|_{L^{1}\left(\mathbf{R}_{x}^{n}\right)}\right\|_{L^{1}\left(\mathbf{R}_{\xi}^{n}\right)} \\
& \approx\left\|\|\langle\xi\rangle^{s} \widehat{\left(h^{\lambda}\right.} * \widehat{\psi} * M_{-x} g_{0}\right)(\xi)\left\|_{L^{1}\left(\mathbf{R}_{\xi}^{n}\right)}\right\|_{L^{1}\left(\mathbf{R}_{x}^{n}\right)} \\
& \leq\| \|\langle\xi\rangle^{s} \widehat{h^{\lambda}}(\xi)\left\|_{L^{1}\left(\mathbf{R}_{\xi}^{n}\right)}\right\|\langle\xi\rangle^{s}\left(\widehat{\psi} * M_{-x} g_{0}\right)(\xi)\left\|_{L^{1}\left(\mathbf{R}_{\xi}^{n}\right)}\right\|_{L^{1}\left(\mathbf{R}_{x}^{n}\right)} \\
& =\left\|\langle\cdot\rangle^{\widehat{h^{\lambda}}}\right\|_{L^{1}}\|\psi\|_{M_{s}^{1,1}} .
\end{aligned}
$$

Since $\widehat{h^{\lambda}}(\zeta)=(2 \pi)^{-n}\left(\widehat{\psi_{\lambda}} * \widehat{f}\right)(\zeta)-f(0) \widehat{\psi_{\lambda}}(\zeta)$ and $\widehat{\psi_{\lambda}}(\zeta)=\frac{1}{\lambda^{n}} \widehat{\psi}\left(\frac{\zeta}{\lambda}\right)$, we have

$$
\begin{aligned}
\widehat{h^{\lambda}}(\zeta) & =\frac{1}{(2 \pi)^{n}} \int_{\mathbf{R}^{n}} \widehat{f}(\eta) \widehat{\psi_{\lambda}}(\zeta-\eta) d \eta-\frac{1}{(2 \pi)^{n}}\left(\int_{\mathbf{R}^{n}} \widehat{f}(\eta) d \eta\right) \widehat{\psi_{\lambda}}(\zeta) \\
& =\frac{1}{(2 \pi \lambda)^{n}} \int_{\mathbf{R}^{n}} \widehat{f}(\eta)\left(\widehat{\psi}\left(\frac{\zeta-\eta}{\lambda}\right)-\widehat{\psi}\left(\frac{\zeta}{\lambda}\right)\right) d \eta
\end{aligned}
$$

and thus we obtain by Lemma 7.3 choosing $\vartheta=\frac{\xi}{\lambda}$ and $\lambda>5$ that

$$
\begin{aligned}
\left\|\langle\cdot\rangle^{s} \widehat{h^{\lambda}}\right\|_{L^{1}\left(\mathbf{R}^{n}\right)} & \lesssim \int_{\mathbf{R}^{n}}\left(\frac{1}{\lambda^{n}} \int_{\mathbf{R}^{n}}\langle\zeta\rangle^{s}\left|\widehat{\psi}\left(\frac{\zeta-\eta}{\lambda}\right)-\widehat{\psi}\left(\frac{\zeta}{\lambda}\right)\right| d \zeta\right)|\widehat{f}(\eta)| d \eta \\
& \lesssim \lambda^{s} \int_{\mathbf{R}^{n}}\left(\int_{\mathbf{R}^{n}}\langle\xi\rangle^{s}\left|\widehat{\psi}\left(\xi-\frac{\eta}{\lambda}\right)-\widehat{\psi}(\xi)\right| d \xi\right)|\widehat{f}(\eta)| d \eta \\
& \lesssim \int_{\mathbf{R}^{n}}|\eta|^{s}\left(\max _{|t| \leq 4}\left|e^{i \frac{\eta}{\lambda} t}-1\right|\right)^{1-s}|\widehat{f}(\eta)| d \eta .
\end{aligned}
$$

We note that $M_{s}^{1,1}\left(\mathbf{R}^{n}\right) \hookrightarrow \mathcal{F} L_{s}^{1}\left(\mathbf{R}^{n}\right)$, and also $\left(\max _{|t| \leq 4}\left|e^{i \frac{\eta}{\lambda} t}-1\right|\right)^{1-s} \leq$ 2 and $\left(\max _{|t| \leq 4}\left|e^{i \frac{\eta}{\lambda} t}-1\right|\right)^{1-s} \rightarrow 0$ as $\lambda \rightarrow \infty$. Therefore the Lebesgue convergence theorem yields that $\left\|\langle\cdot\rangle^{s} \widehat{h^{\lambda}}\right\|_{L^{1}\left(\mathbf{R}^{n}\right)} \rightarrow 0(\lambda \rightarrow \infty)$. Therefore, for any $\varepsilon>0$, there exists $\lambda_{0}>0$ such that $\left\|h^{\lambda_{0}}\right\|_{M_{s}^{1,1}}<\varepsilon$. Hence, by putting $\phi(x)=\psi_{\lambda_{0}}(x)$, we have the desired result.

Next we prepare a lemma, which corresponds to a weighted version of Bhimani [2, Proposition 4.7].

Lemma 7.5. Let $1 \leq p \leq \infty, 0 \leq s<1, f \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right), x_{0} \in \mathbf{R}^{n}$ and $\varepsilon>0$. Then there exists $\tau \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ such that
(i) $\left\|\left(f-f\left(x_{0}\right)\right) \tau\right\|_{M_{s}^{p, 1}}<\varepsilon$
(ii) $\tau(x)=1$ in some neighborhood of $x_{0}$.

Proof. Let $\psi \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ be such that $\psi(x)=1$ on some neighborhood of $x_{0}$, and set $h(x)=\left(f(x)-f\left(x_{0}\right)\right) \psi(x)$. We note that $h\left(x_{0}\right)=0$. Since $h \in M_{s}^{1,1}\left(\mathbf{R}^{n}\right)$, Lemma 7.4 implies that there exists $\phi \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ such that $\left\|\left(h-h\left(x_{0}\right)\right) \phi\right\|_{M_{s}^{1,1}}<\varepsilon$ and $\phi=1$ on some neighborhood of $x_{0}$. Now we define $\tau=\psi \phi \in C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$. Then we see that $\tau=1$ on some neighborhood of $x_{0}$, and we have by $M_{s}^{1,1}\left(\mathbf{R}^{n}\right) \hookrightarrow M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$

$$
\left\|\left(f-f\left(x_{0}\right)\right) \tau\right\|_{M_{s}^{p, 1}}=\left\|\left(h-h\left(x_{0}\right)\right) \phi\right\|_{M_{s}^{p, 1}} \lesssim\left\|\left(h-h\left(x_{0}\right)\right) \phi\right\|_{M_{s}^{1,1}} .
$$

Hence we obtain the desired result.

Remark 7.6. Recall that $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ is a Banach algebra. Then it follows from Lemma 7.5 that $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ satisfies the condition of WienerDitkin (cf. [30, Ch.2, §4.3], [31, Definition 2.4.7]), i.e., for every point $x_{0} \in \mathbf{R}^{n}$ the following holds: for any function $f \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ vanishing at $x_{0}$ and any neighborhood $\mathcal{U}_{0}$ of 0 in $M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, there exists $\tau \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$ such that $(i) \tau$ is constant 1 near $x_{0}$, and (ii) $f \cdot \tau \in \mathcal{U}_{0}$.
7.2. The proof of Theorem 7.1. We first note that $J_{0}\left(\left\{x_{0}\right\}\right) \subset$ $I\left(\left\{x_{0}\right\}\right)$. Since $J\left(\left\{x_{0}\right\}\right)$ is the smallest closed ideal containing $J_{0}\left(\left\{x_{0}\right\}\right)$, it follows from Lemma 4.3 that $J\left(\left\{x_{0}\right\}\right) \subset I\left(\left\{x_{0}\right\}\right)$. We next prove $I\left(\left\{x_{0}\right\}\right) \subset J\left(\left\{x_{0}\right\}\right)$. Since $I\left(\left\{x_{0}\right\}\right)$ is an closed ideal with $J_{0}\left(\left\{x_{0}\right\}\right) \subset$ $I\left(\left\{x_{0}\right\}\right)$, it suffices to prove that $I\left(\left\{x_{0}\right\}\right) \subset \overline{J_{0}\left(\left\{x_{0}\right\}\right)}$. Let $f \in I\left(\left\{x_{0}\right\}\right)$ and $\varepsilon>0$. We note that $f\left(x_{0}\right)=0$. By Lemma 7.5, there exists $\tau \in$ $C_{c}^{\infty}\left(\mathbf{R}^{n}\right)$ such that $\|\tau f\|_{M_{s}^{p, 1}}<\varepsilon$ and $\tau(x)=1$ on some neighborhood of $x_{0}$. Now we set $g=(1-\tau) f$. Then we have $g=f-\tau f \in M_{s}^{p, 1}\left(\mathbf{R}^{n}\right)$, $g(x)=0$ on some neighborhood of $x_{0}$ and $\|f-g\|_{M_{s}^{p, 1}}=\|\tau f\|_{M_{s}^{p, 1}}<\varepsilon$. Hence we obtain the desired result.

## 8. Inclusion relation between $M^{p, 1}$ and $\mathcal{F} A_{p}$

In this section, we consider the inclusion relation between the modulation space $M^{p, 1}(\mathbf{R})$ and the Fourier Segal algebra $\mathcal{F} A_{p}(\mathbf{R})$. Here, $\mathcal{F} A_{p}(\mathbf{R})$ is the space defined by the norm

$$
\|f\|_{\mathcal{F A _ { p }}}=\|f\|_{L^{p}}+\|\widehat{f}\|_{L^{1}}
$$

We note that since $\mathcal{F} A_{p}(\mathbf{R})$ is the Fourier image of Segal algebra $A_{p}(\mathbf{R})$ which is defined by the norm

$$
\|f\|_{A_{p}}=\|\widehat{f}\|_{L^{p}}+\|f\|_{L^{1}}
$$

(see [30], [31, [39] for more details), $\mathcal{F} A_{p}(\mathbf{R})$ is a (abstract) Segal algebra in $A(\mathbf{R})\left(=\mathcal{F} L_{0}^{1}(\mathbf{R})\right)$ in the following sense.
(i) $\mathcal{F} A_{p}(\mathbf{R})$ is a commutative Banach algebra with pointwise multiplication and the norm $\|f\|_{\mathcal{F A}_{p}}$.
(ii) $\mathcal{F} A_{p}(\mathbf{R})$ is a dense subset of the Fourier algebra $A(\mathbf{R})$.
(iii) $\mathcal{F} A_{p}(\mathbf{R})$ is isometrically invariant under modulation operators:

$$
\left\|M_{\xi} f\right\|_{\mathcal{F A}}^{p} 10=\|f\|_{\mathcal{F} A_{p}}, \quad \forall \xi \in \mathbf{R}
$$

Moreover, $\mathcal{F} A_{p}(\mathbf{R})$ has similar properties to $A(\mathbf{R})$ (see [24], [25]). On the other hand, Lemmas [2.2, [2.7] and 2.9 imply that $M^{p, 1}(\mathbf{R}) \hookrightarrow$ $\mathcal{F} A_{p}(\mathbf{R})$ for $1 \leq p \leq 2$. Therefore, it is natural to ask whether $M^{p, 1}(\mathbf{R})$ is a proper subset of $\mathcal{F} A_{p}(\mathbf{R})$.

Theorem 8.1. For $1 \leq p \leq 2$ we have the proper, dense inclusion $M^{p, 1}(\mathbf{R}) \subsetneq \mathcal{F} A_{p}(\mathbf{R})$.

We remark that Losert [27, Theorem 2] implies that Theorem 8.1 holds for the case $p=1$.
8.1. Technical lemma. To prove Theorem 8.1, we prepare the following lemma.

Lemma 8.2. Let $K$ be a compact subset of $\mathbf{R}$. Then for any $\varepsilon>0$, there exist a discrete measure $\mu \in M(\mathbf{R})$ and $m, N \in \mathbf{N}$ for which the following conditions hold.
(i) $\|\mu\|_{M(\mathbf{R})}=1$ and $\|\widehat{\mu}\|_{L^{\infty}}<\varepsilon$.
(ii) supp $\mu$ consists of $2^{m}$ different points and is expressed as

$$
\operatorname{supp} \mu=\left\{x \in \mathbf{R} \mid x=\sum_{j=1}^{m} \alpha_{j} N_{j}, \alpha_{j}=0,1, N_{j}=2^{j-1} N\right\} .
$$

(iii) The sets $\{-x+K \mid x \in \operatorname{supp} \mu\}$ are mutually disjoint.

Proof. Our proof is based on the argument due to Kahane [19, p.3436], which is also known as the Rudin-Shapiro method. Let $\varepsilon>0$ and take $m \in \mathbf{N}$ such that $2^{\frac{1}{2}-\frac{m}{2}}<\varepsilon$. We choose $N \in \mathbf{N}$ such that the sets

$$
\left\{-\sum_{j=1}^{m} \alpha_{j} N_{j}+K \mid \alpha_{j}=0,1, N_{j}=2^{j-1} N\right\}
$$

are mutually disjoint for different choices of $\alpha_{j} \in\{0,1\}$, and then define $\mu_{j}, \nu_{j} \in M(\mathbf{R})(j=1,2, \cdots, m)$ by $\mu_{0}=\nu_{0}=\delta_{0}$ and

$$
\mu_{j}=\mu_{j-1}+\nu_{j-1} * \delta_{N_{j}}, \quad \nu_{j}=\mu_{j-1}-\nu_{j-1} * \delta_{N_{j}} \quad(j=1,2, \cdots, m)
$$

We note that the set $\left\{\sum_{j=1}^{m} \alpha_{j} N_{j} \mid \alpha_{j}=0,1\right\}$ consists of $2^{m}$ different points, and thus we obtain $\left\|\mu_{m}\right\|_{M(\mathbf{R})}=2^{m}$. Moreover, it follows from

$$
\left(\mu_{j-1} \pm \mu_{j-1} * \delta_{N_{j}}\right)^{\wedge}(\xi)=\widehat{\mu_{j-1}}(\xi) \pm \widehat{\nu_{j-1}}(\xi) e^{-i \xi N_{j}} \quad(j=1,2, \cdots, m)
$$

that

$$
\begin{aligned}
\left|\widehat{\mu_{m}}(\xi)\right|^{2}+\left|\widehat{\nu_{m}}(\xi)\right|^{2} & =2\left(\left|\widehat{\mu_{m-1}}(\xi)\right|^{2}+\left|\widehat{\nu_{m-1}}(\xi)\right|^{2}\right) \\
& =\cdots \\
& =2^{m}\left(\left|\widehat{\mu_{0}}(\xi)\right|^{2}+\left|\widehat{\nu_{0}}(\xi)\right|^{2}\right) \\
& =2^{m+1}
\end{aligned}
$$

This gives

$$
\left|\widehat{\mu_{m}}(\xi)\right| \leq\left(\left|\widehat{\mu_{m}}(\xi)\right|^{2}+\left|\widehat{\nu_{m}}(\xi)\right|^{2}\right)^{\frac{1}{2}} \leq 2^{\frac{m+1}{2}}
$$

Now we set $\mu=2^{-m} \mu_{m}$. Then we can easily see $\|\mu\|_{M(\mathbf{R})}=1$ and

$$
\|\widehat{\mu}\|_{L^{\infty}} \leq 2^{-m} 2^{\frac{m+1}{2}}=2^{\frac{1}{2}-\frac{m}{2}}<\varepsilon .
$$

Hence, we obtain the desired result.

Remark 8.3. We note that $\mu$ is also expressed as

$$
\mu=2^{-m} \sum_{\alpha_{j}=0,1} C_{\left(\alpha_{1}, \cdots, \alpha_{2 m}\right)} \delta_{\alpha_{1} N_{1}+\alpha_{2} N_{2}+\cdots+\alpha_{2 m} N_{2 m}},
$$

where each term $C_{\left(\alpha_{1}, \cdots, \alpha_{2 m}\right)}$ is equal to 1 or -1 . For the sake of simplicity, we simply write $\mu=\sum_{j=1}^{2^{m}} a_{j} \delta_{\ell(j)}$ with supp $\mu=\{\ell(j) \in \mathbf{N} \mid j=$ $\left.1,2, \cdots, 2^{m}\right\}$, where $a_{j}=2^{-m}$ or $a_{j}=-2^{-m}$.

Remark 8.4. Let $1 \leq p<2$ and choose $r \in \mathbf{N}$ such that $2^{\frac{1}{2}-r\left(\frac{1}{p}-\frac{1}{2}\right)}<\varepsilon$. In the same way as above, we define $\nu \in M(\mathbf{R})$ by

$$
\nu=2^{-\frac{r}{p}} \mu_{m^{\prime}}=\sum_{j=1}^{2^{r}} b_{j} \delta_{N(j)} .
$$

Then we have $\sum_{j=1}^{2^{r}}\left|b_{j}\right|^{p}=1,\|\widehat{\nu}\|_{L^{\infty}}<\varepsilon$ and the sets $\{-N(j)+$ $K \mid N(j) \in \operatorname{supp} \nu\}$ are mutually disjoint.
8.2. The proof of Theorem 8.1. ( $i$ ) We first consider the case $1 \leq$ $p<2$. As mentioned at the beginning of Section $8, M^{p, 1}(\mathbf{R}) \subset \mathcal{F} A_{p}(\mathbf{R})$ holds. Let $\phi \in C_{c}^{\infty}(\mathbf{R}) \backslash\{0\}$ be such that $K=\operatorname{supp} \phi \subset\left[-\frac{1}{10}, \frac{1}{10}\right]$. Then Lemma 8.2 yields that for any $\varepsilon>0$, there exists $\mu \in M(\mathbf{R})$ and $m \in \mathbf{N}$ such that $\|\mu\|_{M(\mathbf{R})}=1,\|\widehat{\mu}\|_{L^{\infty}}<\varepsilon$ and

$$
\operatorname{supp} \mu=\left\{\ell(j) \in \mathbf{N} \mid j=1,2, \cdots, 2^{m}\right\}
$$

where the sets $\{-\ell(j)+K \mid \ell(j) \in \operatorname{supp} \mu\}$ are mutually disjoint. It follows from Remark 8.3 that $\mu$ can be represented as $\mu=\sum_{j=1}^{2^{m}} a_{j} \delta_{\ell(j)}$ with $\ell(j) \in \operatorname{supp} \mu$ and $a_{j}=2^{-m}$ or $a_{j}=-2^{-m}$. Moreover, since $\widehat{\phi} \in L^{p}(\mathbf{R})$, we see that for any $\eta>0$, there exists a compact subset $K_{\eta}=[-R, R] \subset \mathbf{R}$ for some $R>0$ such that $\int_{\mathbf{R} \backslash K_{\eta}}|\widehat{\phi}(\xi)|^{p} d \xi<\eta$. Furthermore, we have by Remark 8.4 that there exist $r, N \in \mathbf{N}$ and $\nu=\sum_{j=1}^{2^{r}} b_{j} \delta_{N(j)} \in M(\mathbf{R})$ such that $\sum_{j=1}^{2^{r}}\left|b_{j}\right|^{p}=1,\|\widehat{\nu}\|_{L^{\infty}}<\varepsilon$ and

$$
\operatorname{supp} \nu=\left\{N(j) \in \mathbf{N} \mid j=1,2, \cdots, 2^{r}\right\},
$$

where the sets $\left\{-N(j)+K_{\eta} \mid N(j) \in \operatorname{supp} \nu\right\}$ are mutually disjoint, and $b_{j}=2^{-\frac{r}{p}}$ or $b_{j}=-2^{-\frac{r}{p}}$.

Now we define $f$ by $\widehat{f}=\mu *(\widehat{\nu} \phi)$.
Step 1. Firstly, we estimate $\|f\|_{M^{p, 1}}$. Let $\varphi \in \mathcal{S}(\mathbf{R})$ be such that $\sum_{k \in \mathbf{Z}} \varphi(\xi-k)=1$, supp $\varphi \subset[-1,1]$ and $\varphi(\xi)=1$ on $\left[-\frac{1}{10}, \frac{1}{10}\right]$. Since

$$
\widehat{f}(\xi)=\left(\left(\sum_{j=1}^{2^{m}} a_{j} \delta_{\ell(j)}\right) *(\widehat{\nu} \phi)\right)(\xi)=\sum_{j=1}^{2^{m}} a_{j}(\widehat{\nu} \phi)(\xi-\ell(j)),
$$

we have

$$
\varphi(\xi-\ell(k)) \widehat{f}(\xi)=a_{k}(\widehat{\nu} \phi)(\xi-\ell(k))
$$

and

$$
\varphi(D-k) f(x)=\frac{a_{k}}{2 \pi} \int_{\mathbf{R}}(\widehat{\nu} \phi)(\xi-\ell(k)) e^{i x \xi} d \xi=a_{k} e^{i x \ell(k)} \mathcal{F}^{-1}(\widehat{\nu} \phi)(x)
$$

Therefore, we obtain

$$
\|\varphi(D-k) f\|_{L^{p}}=\left|a_{k}\right|\left\|\mathcal{F}^{-1}(\widehat{\nu} \phi)\right\|_{L^{p}}=\left|a_{k}\right|\left\|\nu *\left(\mathcal{F}^{-1} \phi\right)\right\|_{L^{p}} .
$$

On the other hand, since $\nu=\sum_{j=1}^{2^{r}} b_{j} \delta_{N(j)}$, we have

$$
\left\|\nu *\left(\mathcal{F}^{-1} \phi\right)\right\|_{L^{p}}=\left\|\sum_{j=1}^{2^{r}} b_{j}\left(\mathcal{F}^{-1} \phi\right)(\cdot-N(j))\right\|_{L^{p}} .
$$

Moreover, since $\left\{-N(j)+K_{\eta}\right\}$ are mutually disjoint and

$$
\left|A+\sum_{j=1}^{2^{r}} B_{j}\right|^{p} \geq \frac{1}{2^{p}}|A|^{p}-\left|\sum_{j=1}^{2^{r}} B_{j}\right|^{p} \geq \frac{1}{2^{p}}|A|^{p}-2^{r p} \sum_{j=1}^{2^{r}}\left|B_{j}\right|^{p}
$$

we obtain that

$$
\begin{aligned}
& \left|\sum_{j=1}^{2^{r}} b_{j}\left(\mathcal{F}^{-1} \phi\right)(x-N(j))\right|^{p} \\
& =\mid \sum_{j=1}^{2^{r}} b_{j}\left(\left(\chi_{K_{\eta}} \cdot\left(\mathcal{F}^{-1} \phi\right)\right)(x-N(j))+\left.\left(\chi_{\mathbf{R} \backslash K_{\eta}} \cdot\left(\mathcal{F}^{-1} \phi\right)\right)(x-N(j))\right|^{p}\right. \\
& \geq \frac{1}{2^{p}} \sum_{j=1}^{2^{r}}\left|b_{j}\right|^{p}\left|\left(\chi_{K_{\eta}} \cdot\left(\mathcal{F}^{-1} \phi\right)\right)(x-N(j))\right|^{p} \\
& \quad-2^{r p} \sum_{j=1}^{2^{r}}\left|b_{j}\right|^{p}\left|\left(\chi_{\mathbf{R} \backslash K_{\eta}} \cdot\left(\mathcal{F}^{-1} \phi\right)\right)(x-N(j))\right|^{p} .
\end{aligned}
$$

Since $\sum_{j=1}^{2^{r}}\left|b_{j}\right|^{p}=1$, we have

$$
\begin{aligned}
\| \nu & *\left(\mathcal{F}^{-1} \phi\right) \|_{L^{p}}^{p} \\
\geq & \sum_{j=1}^{2^{r}}\left|b_{j}\right|^{p}\left(\frac{1}{2^{p}} \int_{\mathbf{R}}\left|\left(\chi_{K_{\eta}} \cdot\left(\mathcal{F}^{-1} \phi\right)\right)(x-N(j))\right|^{p} d x\right. \\
& \left.-2^{r p} \int_{\mathbf{R}}\left|\left(\chi_{\mathbf{R} \backslash K_{\eta}} \cdot\left(\mathcal{F}^{-1} \phi\right)\right)(x-N(j))\right|^{p} d x\right) \\
= & \sum_{j=1}^{2^{r}}\left|b_{j}\right|^{p}\left(\frac{1}{2^{p}} \int_{K_{\eta}}\left|\mathcal{F}^{-1} \phi(x)\right|^{p} d x-2^{r p} \int_{\mathbf{R} \backslash K_{\eta}}\left|\mathcal{F}^{-1} \phi(x)\right|^{p} d x\right) \\
= & \frac{1}{2^{p}}\left\|\mathcal{F}^{-1} \phi\right\|_{L^{p}}^{p}-\left(1+2^{r p}\right) \eta .
\end{aligned}
$$

Putting $\eta=\frac{1}{2^{p+1}\left(1+2^{r p}\right)}\left\|\mathcal{F}^{-1} \phi\right\|_{L^{p}}^{p}$, we obtain

$$
\left\|\nu *\left(\mathcal{F}^{-1} \phi\right)\right\|_{L^{p}} \geq \frac{1}{2^{1+\frac{1}{p}}}\left\|\mathcal{F}^{-1} \phi\right\|_{L^{p}} .
$$

Hence we have by $\|\mu\|_{M(\mathbf{R})}=\sum_{k=1}^{2^{m}}\left|a_{k}\right|=1$ that $\|f\|_{M^{p, 1}}=\sum_{k \in \mathbf{Z}}\|\phi(D-k) f\|_{L^{p}} \geq \frac{1}{2^{1+\frac{1}{p}}}\left(\sum_{k=1}^{2^{m}}\left|a_{k}\right|\right)\left\|\mathcal{F}^{-1} \phi\right\|_{L^{1}}=\frac{1}{2^{1+\frac{1}{p}}}\left\|\mathcal{F}^{-1} \phi\right\|_{L^{1}}$.

Step 2. Secondly, we show that $\|\widehat{f}\|_{L^{1}} \leq \varepsilon\|\phi\|_{L^{1}}$. Since $\widehat{f}=\mu *(\widehat{\nu} \phi)$, $\|\widehat{\nu}\|_{L^{\infty}}<\varepsilon$ and $\mu=\sum_{j=1}^{2^{m}} a_{j} \delta_{\ell(j)}$ with $\|\mu\|_{M(\mathbf{R})}=\sum_{j=1}^{2^{m}}\left|a_{j}\right|=1$, we obtain

$$
\|\widehat{f}\|_{L^{1}} \leq \sum_{j=1}^{2^{m}}\left|a_{j}\right|\|(\widehat{\nu} \phi)(\cdot-\ell(j))\|_{L^{1}} \leq\|\widehat{\nu}\|_{L^{\infty}}\|\phi\|_{L^{1}} \sum_{j=1}^{2^{m}}\left|a_{j}\right|<\varepsilon\|\phi\|_{L^{1}}
$$

Step 3. Thirdly, we show that $\|f\|_{L^{p}} \leq \varepsilon\left\|\mathcal{F}^{-1} \phi\right\|_{L^{p}}$. We note that

$$
\begin{aligned}
f(x) & =\mathcal{F}^{-1}(\mu *(\widehat{\nu} \phi))(x) \\
& =\mathcal{F}^{-1}\left(\sum_{j=1}^{2^{m}} a_{j}(\widehat{\nu} \phi)(\cdot-\ell(j))\right)(x) \\
& =\frac{1}{2 \pi} \sum_{j=1}^{2^{m}} a_{j}\left(\int_{\mathbf{R}} \widehat{\nu}(\xi-\ell(j)) \phi(\xi-\ell(j)) e^{i x \xi} d \xi\right) \\
& =\sum_{j=1}^{2^{m}} a_{j} e^{i x \ell(j)} \mathcal{F}^{-1}(\widehat{\nu} \phi)(x) \\
& =(\widehat{\nu}(-x))\left(\left(\mu *\left(\mathcal{F}^{-1} \phi\right)\right)(x)\right) .
\end{aligned}
$$

Therefore, we obtain
$\|f\|_{L^{p}} \leq\|\widehat{\nu}\|_{L^{\infty}}\left\|\mu *\left(\mathcal{F}^{-1} \phi\right)\right\|_{L^{p}} \leq\|\widehat{\nu}\|_{L^{\infty}}\|\nu\|_{M(\mathbf{R})}\left\|\mathcal{F}^{-1} \phi\right\|_{L^{p}} \leq \varepsilon\left\|\mathcal{F}^{-1} \phi\right\|_{L^{p}}$.
Step 4. We note that if $M^{p, 1}(\mathbf{R})=\mathcal{F} A_{p}(\mathbf{R})$ set-theoretically, then the closed graph theorem implies that the norms on both spaces are equivalent. Therefore we have
$\frac{1}{2^{1+\frac{1}{p}}}\left\|\mathcal{F}^{-1} \phi\right\|_{L^{1}} \leq\|f\|_{M^{p, 1}} \lesssim\|f\|_{\mathcal{F A}(\mathbf{R})}=\|f\|_{L^{p}}+\|\widehat{f}\|_{L^{1}} \leq \varepsilon\left(\|\phi\|_{L^{p}}+\left\|\mathcal{F}^{-1} \phi\right\|_{L^{1}}\right)$.
Since $\phi \neq 0$, this is impossible. Hence we obtain the desired result.
(ii) Finally, we consider the case $p=2$. Set $I_{k}=\left[k-\frac{1}{\left(\log _{e} k\right)^{2}}, k+\frac{1}{\left(\log _{e} k\right)^{2}}\right]$ $(k \in \mathbf{N})$ and define $f$ by $\widehat{f}(\xi)=\sum_{k=e^{10}}^{\infty} \frac{\chi_{I_{k}}(\xi)}{k}$, where $\chi_{E}$ denotes the characteristic function of a set $E \subset \mathbf{R}$, i.e., $\chi_{E}(x)=1$ (if $x \in E$ ), $=0$ (if $x \notin E$ ). Moreover, let $\varphi \in \mathcal{S}(\mathbf{R})$ be such that $\sum_{k \in \mathbf{Z}} \varphi(\xi-k)=1$ $(\xi \in \mathbf{R})$ and $\varphi(\xi)=1$ on $\left[-\frac{1}{10}, \frac{1}{10}\right]$. Then we have

$$
\|\widehat{f}\|_{L^{1}} \leq \sum_{k \in \mathbf{Z}}\|\varphi(\cdot-k) \widehat{f}\|_{L^{1}} \leq \sum_{k=e^{10}}^{\infty} \frac{2}{k\left(\log _{e} k\right)^{2}}<\infty
$$

and

$$
\|f\|_{L^{2}} \approx\|\widehat{f}\|_{L^{2}}=\left(\sum_{k=e^{10}}^{\infty} \frac{\left|I_{k}\right|}{k^{2}}\right)^{\frac{1}{2}}=\left(\sum_{k=e^{10}}^{\infty} \frac{2}{k^{2}\left(\log _{e} k\right)^{2}}\right)^{\frac{1}{2}}<\infty .
$$

Therefore we obtain that $f \in \mathcal{F} A_{2}(\mathbf{R})$. On the other hand, it follows form the Plancherel theorem that

$$
\|f\|_{M^{2,1}} \approx \sum_{k \in \mathbf{Z}}\|\varphi(\cdot-k) \widehat{f}\|_{L^{2}}=\sum_{k=e^{10}}^{\infty} \frac{\left\|\chi_{I_{k}}\right\|_{L^{2}}}{k}=\sum_{k=e^{10}}^{\infty} \frac{2}{k\left(\log _{e} k\right)}=\infty
$$

Thus we have $f \notin M^{2,1}(\mathbf{R})$. Hence we obtain $f \in \mathcal{F} A_{2}(\mathbf{R}) \backslash M^{2,1}(\mathbf{R})$.
